

FILM PERMIT PROCEDURES:

1. Film permit applications must be completed and accompanied by the following:
 - Film Crew Page signed by the property owner ***and*** the authorized film production representative.
 - Valid Certificate of Insurance with the Town of Golden Beach as the Certificate Holder
 - Hold Harmless Letter
 - Letter of Notification to the Neighbors – letters must be mailed and copies of envelopes addressed and with postage affixed must accompany the permit application.
 - Parking Plan Diagram
 - Check for the appropriate fee

2. Schedule of fees:
 - 1-10 people \$300.00 per day
 - 11-20 people \$500.00 per day
 - 20 + people \$700.00 per day for the first 5 days
 - 20 + people \$1100.00 per day for 6 or more days

3. An off duty officer must be hired at \$40.00 per hour for a 4 hour minimum if there are more than 20 people involved in film shoot.

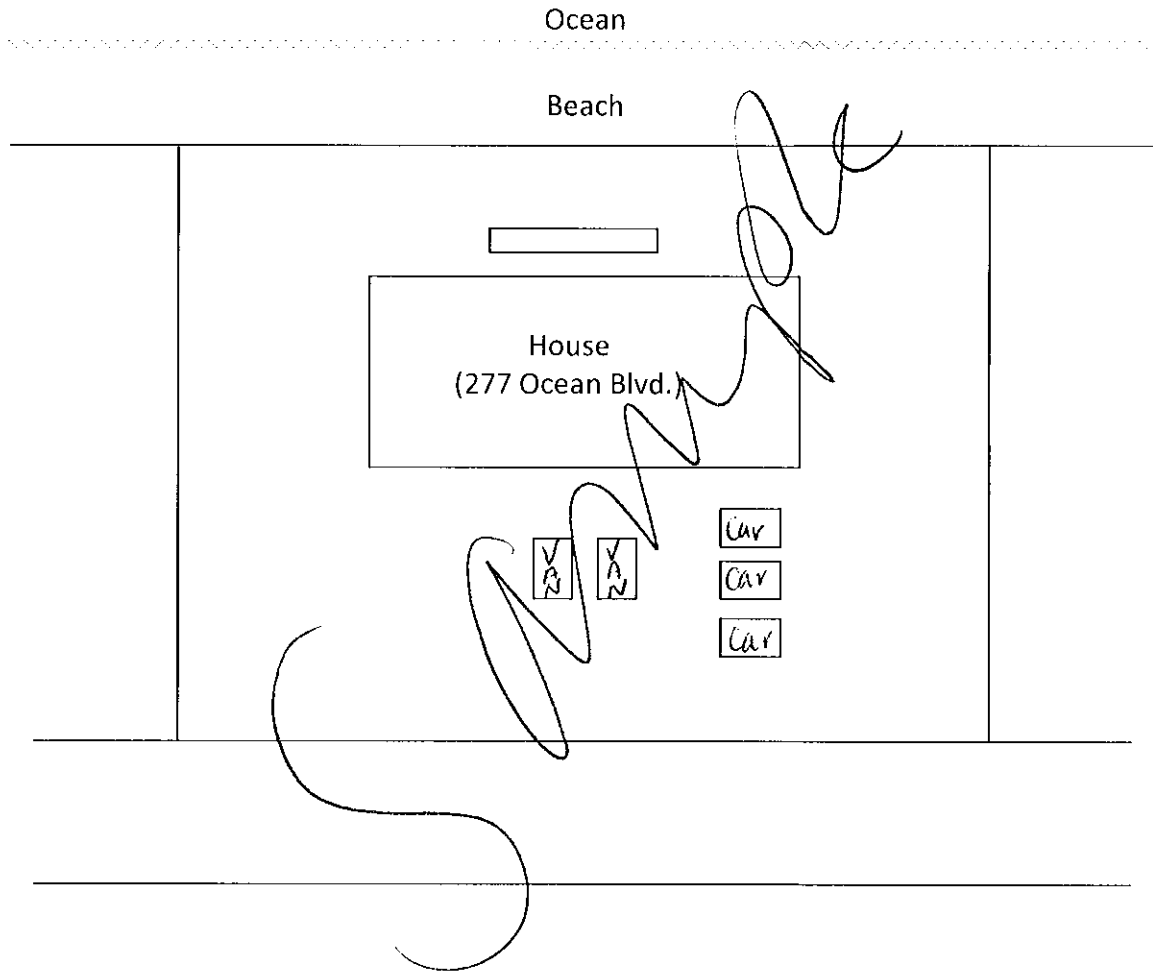
