4	and found that certain modifications are necessary and desirable to further regulate rooftop
5	activities and uses, including rooftop elevator vestibules and exterior staircases on single-
6	family homes; and
7	WHEREAS, a public meeting was held before the Local Planning Agency (LPA) of
8	the Town to review the proposed modifications to the Town's Land Development
9	Regulations; and
10	WHEREAS, the Town Council held duly advertised public meetings to consider the
11	proposed modifications to the Town's Land Development Regulations.

38 39 40	(2) The usable area must be set back a minimum of ten feet from the edge of the roof in all directions except from the rear (ocean front).

No exterior of any Structure may be painted, stained, or otherwise colorized with a color(s) other than a color(s) that is the same or substantially similar to a color within a paint palate palette established and approved by the Town Council. All colors, including accent colors, must be complimentary and harmonious with other materials and components, including roof tiles incorporated into the Structure. Any variation from this standard shall be subject to the zoning reiewTown Building Official's prior approval, or the Town's Building Regulation Advisory Board's approval on appeal of the zoning reviewBuilding Official's decision.
 - (b) Paint permit color review process. A Town paint permit shall be required prior to painting or repainting of the exterior of any Structure. Any person wishing to paint the exterior of a structure shall submit the proposed paint color sample(s), together with a form prepared by the Town intended to provide information as to the site location, property owner, painting contractor (if any), and proposed areas where the paint is intended to be applied (illustrations / photos), to the Building Department who shall review the proposal

F. GOOD AND WELFARE

Donna Smith, 220 South Island Drive

Stated that she has always felt safe in Town, but as of lately feels that the police presence in Town is not what it used to be. The gate arm is always opening, even when she has been in a rental car. Recently knocked on the command post vehicle door and no one answered. Just wondering where the police are.

Mayor Michael Addicott, 155 Golden Beach Drive

Read a letter into the record concerning the health and safety hazards of allowing dogs on the Town's beaches.

G. MAYOR'S REPORT

Spoke on the guardhouse and beach pavilion projects.

Spoke on additional security throughout Town.

Security and safety is a concern and something that the Town is looking into.

Adding additional cameras and will be working to enhance security in Town.

Adding deterrents for speeders on A1A that will hopefully help with that issue.

Regarding dogs on the beach, stated that Mayor Addicott did have some valid points. However, the event that the Town did have was a big success and it was not at the beach pavilion area, it was just north of there on a resident's property. Hopefully can figure out a solution to Mayor Addicott's points.

H. COUNCIL COMMENTS

Councilmember Bernstein

Mentioned that he happened to stop by the New Year's event in Town and that it was a great event.

Thanked resident Donna Smith for her observations about the safety in Town and that it is an important issue to the Council.

Thinks that the lighting project with FPL should help with some of the safety issues as well as beautify the Town.

Vice Mayor Lusskin

Encouraged residents to leave their lights on at night outside of their homes as a deterrent to possible criminals.

Stated that the incident that took place in Town took place early in the evening, and it was a valiant effort put on by the Police Department. Wondering if at that moment when the incident occurred if the Town should not have considered a CodeRed phone call. Understands that this could create chaos, but it was so early in the evening that she does not know what the right answer is.

Also getting some phone calls about the pedestrian gates and whether or not to lock them or keep them open. Doesn't know what the answer is, but wanted to bring up that this is an ongoing issue for residents.

Also getting phone calls from residents in a certain area of Town that are having continual issues with internet and cable service from Atlantic broadband.

Councilmember Mendal

Stated that movie night was great. Thinks that we should have more of those. People really love it.

Stated that residents have two people residents have told him that they have gotten nails stuck in their tires due to the construction at the guardhouse.

The **Town Manager** stated that they have not started using nails yet, so it could not be coming from the work being done at the guardhouse.

Councilmember Mendal also stated that some residents who work regular business hours have inquired about Town Hall being open once or twice a month on extended or after regular business hours.

I. TOWN MANAGER REPORT

Stated that the Administration is still working with FEMA to get the Town's reimbursement from them.

The police gatehouse is moving along. Did approve the replacement of the roof and that will begin this week.

Beach pavilion is moving along. Gates around Town will be addressed during that item. Public safety committee meeting is next Wednesday at 6 p.m. at Town Hall.

There will be a town forum on public safety on February 6th at 6 p.m., that is open to the public.

Do know that the residents are extremely concerned. When you do not see officers, it does not mean that they are not in Town. Sometimes staffing levels are not enough. To assist this the Town now has plain-clothes officers and plain cars in Town too. We do recommend that you call the substation if you need assistance, however if you have an emergency call 9-1-1. The difference between a 9-1-1 call response and a regular guardhouse call could be a 6-minute response time difference.

Vice Mayor Lusskin recommended that something be placed in the newsletter explaining the importance of calling 9-1-1 in an emergency.

Town Manager spoke on the CodeRed issue stating that we do not want a CodeRed message to go out that will put an officer's life in danger as well as the residents' life. Also asked residents with alarm systems in their homes to please call the alarm companies, and register the Town substation first and then themselves.

Town Manager stated that the Town would be undertaking a review to enact a lighting ordinance that will be coming out in March. Also will be changing the code to call for certification/recertification of seawalls, allowing for a minimum of 5 feet and a maximum of 6 feet.

Also stated for the record that the dog event was held on private, not public property.

Town Manager explained that the \$16,000 is the balance left in the project budget and is not how much the bathroom will cost alone, and the gate arms are not related to this and will discuss more in item #8.

After the vote, the **Town Manager** gave an update on the beach budget. There are no change orders that have been approved yet. There is a possible change order coming because we originally designed the beach with only 10 piles we're now putting in 29 piles so there is about \$19,000 piling work that is still underneath the budget. He also stated that the Mayor and him approved the under siding of the men's and women's bathroom – that's about \$11,000. **Town Manager** mentioned that what will come to the Council if it is more than \$25,000 is the painting, sand blasting, and replacing of the terrazzo floor. Still within budget for the Beach Pavilion project.

Town Manager stated that a break away arm allows the gate arm to be more flexible and not break every time someone hits it.

Town Manager stated that the majority of this item is due to an analog CCTV system the Town installed 9 years ago. We have since gone digital with our system. We are now installing new digital cameras and adding new cameras in the gatehouse, two cameras in Tweddle Park, one by the roll up in the back where we store most of our expensive items, behind Town Hall, as well as replaces all the analog cameras throughout Town. This item does not include new cameras for the streets. That is another item that will be brought to the Council in April.

Mayor Singer stated that this is being paid for with LETF money.

Town Manager reminded the Council that we are using LETF dollars and we currently have over \$550,000 which still leaves us with about \$400,000 in LETF monies.

The motion passed.

Town Manager spoke on this item and the next two items at the same time.

Town Manager stated that what was originally a \$3 million lighting project has gone down in price now that the community is going with FPL, and allowing FPL to come in and replace all the current lights with LED lights. There is a disadvantage and an advantage to an LED light. Many residents may not like the glow of an LED light because it is a white glow and the Town currently has an orange glow, but there are three levels of intensity of the white glow and we are going with the lowest one, which means a warmer white glow, but it is still a white glow. We currently have 120 lights in Town, and we are adding 60 new lights. Right now, we have our lights placed at random, on Golden Beach Drive they will be positioned diagonal from each other with equal distance. Most islands are getting six additional lights; all parks will also have lights, which they do not have now. FPL allows us to only pay for three things upfront and finance the rest of the project. What we are paying upfront for is the book value to our lights, the removal of all the poles, all the new conduits, wiring to the 60 new lights, and moving the lights from behind the sidewalk into the middle of the green way.

Town Manager reminded the Council that we received \$100,000 dollars from the State of Florida for this project, so we will be out of pocket very little upfront. We will be financing the value of this new system on a moving forward basis. We will go from what we are currently paying which is \$2,300 dollars a month for street lighting to \$5,500. Keep in mind that we are adding 60 new lights, financing 180 posts, heads, blubs, and including ongoing maintenance. This is a no brainer. We will get a lot of push back because many of our residents will not like the white glow, or the fixtures that we choose but we had a very limited number of fixtures to choose from. We are hoping to have all the lights installed by the end of this year.

Councilmember Bernstein asked if the Town has done any type of light study.

Town Manager stated that the Town has done two lighting studies. Four years ago, the Town hired Bailey Engineering to do a photometric reading of the Town. Based on the readings it was decided whether the lights were going to be ten feet apart or thirty feet apart because of the intensity of the white glow. The lights will be aiming towards the streets, not the homes.

Councilmember Bernstein asked if in the photometric study has there been a comparison to what it is to what it is going to be.

Town Manager stated that no and it would not make a difference because with this tariff system with FPL these are the only options available to the Town.

Councilmember Bernstein stated that his concern is that the Town does not end up looking like Disney World.

Vice Mayor Lusskin asked about the current lights.

Town Manager stated that when you add a white light it will be very visible, it will also look wider and that all the current lights are being replaced with the white lights.

Councilmember Mendal asked if one of the new lights will be placed by the dog park because it is dark currently.

Town Manager stated that we ordered four solar powered LED lights from Home Depot and they should have already been installed. The Police Chief will follow up on that.

Councilmember Mendal stated one final thing is to be very cognizant and be aware of how bright some areas are going to be.

P. DISCUSSION & DIRECTION TO TOWN MANAGER

Mayor Glenn Singer:

 Possibility of allowing business activities at beach pavilion for food and bike sharing program

Mayor Singer stated that Town code currently prohibits business activities in Town. Mentioned that the Town revised the code to allow enterprise activities at the beach for payment by residents. Also stated that there is a bike-sharing program that people can pay to essentially rent a bike. The program thats available to our Town does not work for us, but the program on south beach would. Revising the code can give us the ability and flexibility to offer some of these options.

Vice Mayor Lusskin asked how this would work with the charter prohibiting this activity.

Town Manger stated that this ordinance would change that. It would allow it so long as it is a government-sponsored event.

 Possibility of selling the boat dock lot and Town Hall lot to be voted on in the August primary election

Mayor Singer stated that the Town is in the process of looking to construct a civic center, Town Hall, and a fire station on A1A. Based on the survey a high number of the residents would love to have a gym, and a civic center in Town Hall where residents can rent it. The

estimated costs we're looking at could be as much as 10 million dollars or higher. We have different ways to raise the funds or absorb some of the costs. Two other possibilities would be to sell the two lots the Town owns one being the marine boat dock on Center Island Drive which is about a 100 foot lot if we were to sell it could go for about 6 million dollars. When the Mayor fist thought of the idea, he thought it was a great idea but after going out there and looking at it realized that, it is a very special lot with a lot of history to it. The more he thought about it the more he realized that he really did not want to sell the lot. Than the Manger thought of a great idea of keeping the Town Hall around the same current area it is in and building the civic center where the Boat Dock is.

Town Manager stated that this would drive the project budget up because it now becomes two separate projects

Mayor Singer stated that he would be against selling it to a resident and building a home but would not be against keeping it within the Town and making it a community center.

Councilmember Bernstein mentioned that the surrounding residents might be against having a civic center where all of the Residents would be coming to right next door to them.

Mayor Singer stated the other option would be to sell the area behind Town Hall where the maintenance department is. Also that if we put Town Hall on A1A that land where it currently is could be sold and could fetch about 2 million dollars.

Councilmember Mendal mentioned that from his understanding we do not a referendum for that.

Town Manager stated that no, we do not but there is a lot of legal work that will go into that. The attorneys already began looking in to it and that he will also tell the attorneys to begin looking into referendum language and possible referendum questioning for selling the lot or financing a bond for the civic center, than ask the residents if they would vote for on a new G.O. Bond for the purposes of building a Civic Center. Stated for the record that this would go before the Town as a General Obligation Bond question at the August primary election.

Vice Mayor Judy Lusskin: None Requested

Councilmember Kenneth Bernstein: None Requested

Councilmember Amy Isackson-Rojas: None Requested

Councilmember Jaime Mendal:

Pedestrian Gates
Stated that he is getting many complaints about the locking of the pedestrian gates and the consistency of locking them. Stated that there are so many ways around those gates that he does not see the point of locking them.

Town Manager stated that the Town just signed a contract to put in new gates. They will all be contiguous.

Councilmember Mendal feels that a greater deterrent would be having cameras on the actual pedestrian gates.

Town Manager posed the questions should the Town have gates, what time to lock them, and should they have locks.

Town Mayor stated that the gates should be locked at 8:00 P.M.

Councilmember Mendal argued that that time is still too early.

Town Mayor determined the gate closing time as 10 p.m. to 6 a.m. all pedestrian gates will be locked during this time.

Code Red - Asked about issuing them for emergency situations

Town Manager stated that we will not act irresponsible out of havoc, aggravation, fear or concern. As the Town's chief executive officer, he is tasked with making those tough decisions and will not exercise that duty in a reckless manner. Respectfully understands his concerns, but does not want to overuse the system. If Code Red is misused people become desensitized to it.

Councilmember Mendal stated that they already overuse it. Also that it is being used for traffic news.

Town Manager stated that when there is a road closure for longer than four hours and fatalities that calls for a Code Red.

Councilmember Mendal posed the question that the Town has used Code Red to announce Town events.

Town Manager Stated that in this Council back in 2008 when Code Red was purchased that Council instructed this Administration to use Code Red for Town events.

Councilmember Mendal asked if there was a written protocol to the severity of a situation that would lead to the issuance of a Code Red. **Town Manager** stated there is not, it is absolutely at his discretion. Also stated that the Town would have to come up with thousands of

scenarios to decide the severity of a situation. He also called surrounding City Manager's offices and their protocol to exercise CodeRed is always at the discretion of the Chief Administrator or strong Mayors discretion. In the Chief Administrators absence it goes to the Chief of Police with the consultation of the Town Clerk.

Mayor Singer agreed with the Town Manager that you do not want to start pre-chaos and that he has used his discrepancy on when to use Code Red and when not to.

Vice Mayor Lusskin stated she understand that there are pros and cons to using Code Red in a situation like the robbery that occurred. Also suggested that we have a community watch to keep watch.

Town Manager stated that during the frustration period we do send out information to our elected officials so they can be prepared for when the influx of calls come out. It is also part of our extended communication program that our elected officials serve as conduits to each concern to disseminate facts to end rumors. Manager strongly suggests residents call the Gatehouse when they need information about anything or they can call him.

Town Manager Alexander Diaz:
None Requested

Town Manager asked that the Councilmembers come meet with him individually to discuss amenities for North and Singer Park.

Town Manager stated that both Mayor Singer and Councilmember Mendal will be traveling with him on official Town business to Dade Days in Tallahassee for possible funding for a new Civic Center and specifically \$500,000 for a new pump station on Center Island. Also reminded residents that the following Wednesday there will be a public safety meeting chaired by Chief Herbello, and the Wednesday following that there will be a community workshop on public safety. The Town Manager reminded the Council of the next Regular Town Council Meeting scheduled for February 20.

Q. ADJOURNMENT:

A motion to adjourn the Council Meeting was made by <u>Vice Mayor Lusskin</u>, seconded by <u>Councilmember Mendal</u>.

Consensus vote <u>4</u> Ayes <u>0</u> Nays. Motion passes.

The meeting adjourned at 10:06 p.m.

This is a new benefit program being offered to our employees. With the approval of the new collective bargaining agreement on August 22, 2017, a Retirement Health Savings program was agreed to. Given that the International City Management Association Retirement Corporation (ICMA-RC) is the Town's current provider for the 401(k) and the 457 programs, having them also manage the new RHSP keeps most of our offerings with a single administrator.

The agreement attached is needed to implement the new RHSP.

Fiscal Impact:

Employees are allowed to contribute up to the maximum allowable by the Internal Revenue Service.

The Town is to match dollar-for-dollar up to an annual maximum of \$500 per participating employee.

WHEREAS, the Town has determined that the establishment of the Program for employees serves the above objectives; and

WHEREAS, the Town has determined that it is in its best interests to establish a Program for all employees on the same terms as agreed to by the Town and the Florida State Lodge, Fraternal Order of Police, Inc. (the "Union") in the ratified 2017 - 2020 collective bargaining agreement.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE **TOWN OF GOLDEN BEACH, FLORIDA:**

<u>Section 1.</u> Recitals Adopted. Each of the recitals stated above is hereby adopted and confirmed.

Section 2. Establishment of RHS Program. The Town hereby adopts the Program for its employees in the form of the ICMA Retirement Corporation's VantageCare Retirement Health Savings Program through the Town's integral part trust ("Trust") and welfare benefits plan (the "Plan"). The assets of the Plan shall be held in trust, with the Town serving as trustee for the exclusive benefit of Plan participants, their survivors and their beneficiaries, and the assets of the Plan shall not be diverted to any other purpose prior to the satisfaction of all liabilities of the Plan.

<u>Section 3</u>. <u>Authorization to Contribute Matching Funds and Permit the Use of Leave Benefits.</u> The Town shall match dollar-for-dollar employee contributions up to five-hundred dollars (\$500.00) annually. Each eligible employee shall also be allowed to use vacation leave for contributions. In the last year of Town employment, employees are permitted to use sick leave to contribute; however, this usage will decrease the 750 hour sick leave maximum at retirement/separation.

Section 4. Authorization of Town Officials; Implementation. The Town Mayor and Manager are authorized to take all action necessary to implement this Resolution and establish the Plan under these terms and conditions, and to forward all necessary documents as may be required to establish the benefit and execute any required agreements, trusts or documents.

Conceptual Site Plan for Play Equipment Town of Golden Beach | Florida








