The Manager responded yes and the financial impact was \$46,500 and that the Town Manager was not included in the bonuses presented tonight. Council Member Einstein asked what was the final cost of living increase for the Town. The Manager went on to explain that the cost of living that was approved in the budget for next fiscal year was 3.5% and that the local area cost of living was 4.4%.
