Town Manager stated that this is similar to what the Town has done in the last two years, setting the ceiling of how high the millage rate for the Town will be. Although the Town sets it high, the f/y 2012-2013 budget is being prepared assuming a combined millage of 8.50 mills – which is what it has been since the f/y 2007-2008 budget. At the August meeting, the budget will be presented with a combined millage of 8.50. The Town is setting the first budget meeting for the week of September 11th. Also, the f/y 2011-2012 budget was submitted to General Finance Officers Association, and the Town received the budget award.
