

MINUTES OF THE SPECIAL MEETING
OF THE TOWN COUNCIL OF THE TOWN OF
GOLDEN BEACH, FLORIDA

August 10th, 1959

A Special Meeting of the Town Council of the Town of Golden Beach, Florida was held on Monday, August 10th, 1959, at 11:00 o'clock in the morning at the Town Hall. Upon roll call the following members were found to be present constituting all of the Members of the Council.

The Meeting was called to order by the President, Mr. N. B. Ornitz who acted as Chairman of the Meeting and Mrs. Laurita Chapman acted as Secretary.

The President, Mr. N. B. Ornitz stated that the purpose of the Special Meeting was to discuss granting permission to the Peoples Gas Company Inc., to do the necessary work in order that the residents of the Town of Golden Beach may avail themselves of the use of natural gas, which is to be supplied by the Peoples Gas Company Inc. in connection with the granting of a Franchise to said Company, the same being approved at a Special Election held in this regard.

The Council President Mr. N. B. Ornitz, thereupon presented Ordinance No. 84 entitled: "AN ORDINANCE AMENDING ORDINANCE NO. 24, ORDINANCE NO. 52, AND ORDINANCE NO. 59, TO PERMIT GAS COMPANIES, BOTH BOTTLE AND BULK, TO RENEW HOT WATER HEATERS AND TO DO PLUMBING WORK NECESSARY UPON SECURING THE SAME PERMIT NOT REQUIRED OF PLUMBERS PROVIDING THAT WORK IS DONE BY MASTER PLUMBERS OR MASTER GAS FITTERS PROVIDING SUCH WORK DOES NOT REQUIRE THE HEATERS TO BE PLACED MORE THAN 5 FEET FROM PERMANENT PLUMBING OUTLETS."

This being an emergency measure, the Council President Mr. N. B. Ornitz gave this Ordinance its first, second and third reading, and upon the readings of this Ordinance, by the Council President, Mr. N. B. Ornitz, a roll call was taken as follows:

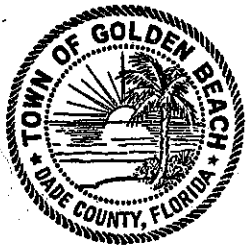
