

MINUTES OF THE SPECIAL MEETING OF THE TOWN
COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA

February 13th, 1952

A special meeting of the Town Council of the Town Of Golden Beach, Florida, was held on Wednesday, February 13th, 1952 in the Town Hall at 10:00 o'clock in the morning. Upon roll call the following members were found to be present, constituting a quorum of the Council

The meeting was called to order by the President, Mr. Haig M. Boyajohn, who acted as Chairman of the Meeting and Mrs. Laurita Chapman acted as Secretary.

The President, Mr. Haig M. Boyajohn, stated that the purpose of this special meeting was to discuss and pass the Ordinance of the Code of Laws Of The Town Of Golden Beach, Florida and an emergence Ordinance prohibiting noises within the Town Of Golden Beach, Florida.

The President, Mr. Haig M. Boyajohn, presented to the members of the Council, Ordinance No. 52 entitled: "AN ORDINANCE OF THE TOWN OF GOLDEN BEACH, FLORIDA, TO REGULATE AND RESTRICT THE ERECTION, RECONSTRUCTION, ALTERATION, LOCATION AND USE OF BUILDINGS: TO REGULATE AND RESTRICT BUILDING LINES AND THE PERCENTAGE OF LOTS THAT MAY BE OCCUPIED AND THE DENSITY OF POPULATION, AND FOR SAID PURPOSES TO DIVIDE THE TOWN OF GOLDEN BEACH INTO ZONES, AND FOR EACH SAID ZONE TO IMPOSE REGULATIONS AND RESTRICTION UNDER WHICH BUILDINGS MAY BE PERMITTED TO BE ERECTED, RECONSTRUCTED OR USED, AND TO PRESCRIBE PENALTIES FOR THE VIOLATION OF THE PROVISIONS OF THIS ORDINANCE, AND ALSO PROVIDE FOR ITS ENFORCEMENT".

This Ordinance was read by the President, Mr. Haig M. Boyajohn, and each paragraph of the twenty pages was discussed. Councilman E. F. Guenther took over the reading of this Ordinance on Page 10. Several corrections were offered and same met the approval of the entire council and the Town Attorney, Mr. Francis M. Miller.

Upon the reading of this Ordinance, a vote was made as follows:-

Thereupon, this Ordinance which passed its first reading, at the Regular Meeting of the Town Council held on December 18th, 1951 and passed its second reading at the regular meeting of the Town Council held on January 29th, 1952, passed its third reading at this meeting and was declared adopted by the President, Mr. Haig M. Boyajohn.

The Commissioner of Fire And Police, Mr. E. F. Guenther brought up the matter of prohibiting certain noises in the Town Of Golden Beach, Florida, whereupon the President, Mr. Haig M. Boyajohn, presented Ordinance No. 53, which Councilman E. F. Guenther read, entitled: "AN ORDINANCE OF THE TOWN OF GOLDEN BEACH, FLORIDA, CLASSIFYING, REGULATING AND/OR PROHIBITING CERTAIN NOISES IN SAID TOWN AND FIXING PENALTIES FOR VIOLATION THEREOF."

This Ordinance was submitted as an emergency Ordinance and was given its first, second and third reading and upon motion by Councilman Bennett R. Paulsen and seconded by Councilman Burt Hengeveld, and unanimously carried, said Ordinance No. 53 was declared adopted.

There being no further business to come before the Council, upon motion by Councilman Burt Hengeveld and seconded by Councilman Bennett R. Paulsen, the meeting adjourned.
