MINUTES OF THE REGULAR MEETING OF THE

TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA

February 17, 1948

The regular meeting of the Town Council of the Town of Golden Beach, Florida, was held on February 17, 1948, at 3 p. m. at the Town Hall and upon roll call the following members were found to be present, constituting a quorum of the Council: - Mr. James T. Hennegan

Mr. Martin L. Pulcher, President of the Town Council, being absent. Mr. R. H. George was elected to serve as President Pro Tem of the meeting and acting President of the Council.

Mr. Fred G. Gamer, Deputy Town Clerk, being absent because of illness, Mr. Francis M. Miller was requested to act as Secretary of the meeting

The Chairman, Mr. R. H. George, thereupon called upon the Secretary of the meeting for the reading of the minutes of the of the meeting. regular meeting held on January 20, 1948.

After the reading of these minutes, Councilman William A. Mentzer moved, which motion was seconded by Councilman G. A. Mayon, that the minutes be approved as read, which motion was

The Secretary thereupon presented the cash report of the unanimously carried. Deputy Town Clerk covering the month of January, 1948. motion by Councilman William A. Mentzer and seconded by Councilman G. A. Mavon, this cash report was unanimously approved and ratiried and ordered attached to these minutes.

The Town Attorney and Acting Secretary of the meeting, then presented Ordinance No. 35, entitled

AN ORDINANCE OF THE TOWN OF GOLDEN BEACH LICENSTING CARDENERS AND GARDENING CONTRACTORS AND LANDSCAPE ARCHITECTS TO DOBUSINESS WITHIN THE LIMITS OF THE TOWN OF GOLDEN BEACH AND PROVIDING FOR THE CANCELLATION OF SAID LICENSE FOR CAUSE AND FURTHER PROVIDING FOR A PENALTY FOR THE VIOLATION OF THIS ORDINANCE

which Ordinance was read three times and was passed as an emergency measure, all Councilmen present voting in the affirmative, upon a roll call being taken, and a copy immediately given to the Town Superintendent with instructions to him to see that the provisions thereof were carried out.

The Town Attorney then presented a Resolution requesting that the Town Attorney take such necessary legal action as may be that the Town Attorney take such necessary legal action as may be the required to join with other municipalities in an effort to have the required to join with other municipalities in an effort to have the required Dade County Merger Amendment declared unconstitutional. This Resolution read as follows:

"BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOIDEN BEACH, FLORIDA:

Section 1. That the proposed Amendment to Article 8 of the Constitution of the State of Florida providing for the merger of municipalities in Dade County with the County government and laws enacted in support of such a ment and laws enacted in support of such a proposed amendment will come before the people of Dade County for voting on May 25, 1948, and of Dade County for voting on May 25, 1948, and it is the opinion of the members of the Town Council of Golden Beach that the adoption of said Amendment and the forcing of Golden Beach into the City of Miami, as provided in said Amendment, would not be for the best interests of the people of Golden Beach.

Sec. 2. The Town Council is advised that a majority of the municipalities of Dade County intend to institute litigation to test the constitutionality of the said Merger Amendment, and it is hereby declared desirable for the Town of Golden Beach to participate in such legal test, provided the cost to the Town of Golden Beach provided the cost to the Town of Golden Beach shall not exceed the Town's proportionate share as such expense may bear to the taxable assessment of the property within the limits of the

Town of Golden Beach, and it has been estimated that the total cost of such litigation will approximate \$8000.00, which sum will be distributed among municipalities and certain sections of Dade County.

Sec. 3. That there is hereby appropriated out of the Town treasury a sum of money not to exceed \$300.00 for the participation of the Town of Golden Beach in such legal action.

PASSED AND ADOPTED this 17th day of February, 1948".

Upon a roll call being taken, the same was unanimously adopted and the Town Attorney was instructed to call upon the Town Clerk for such sum of money as may be required in fulfillment of the Resolution.

The Police Superintendent then discussed conditions of the Town and told the Council that Mr. Robert H. George had donated a Cletrac to the Town, which was of great value to him in his work and also an asset which the Town was very much in need.

Councilman Mentzer and Councilman Mayon moved and seconded that a vote of thanks be given to Mr. George for his generous gift to the Town. This was put to a vote by the Acting Clerk and was a manimously carried.

The matter of building, driving of pile and building inspection was discussed at some length and the Clerk was directed to notify the Town architect and Town Building Inspector that better inspections must be made and also to notify them that there is a forty-foot set back on the west side of Ocean Boulevard. The Mayor was also directed to confer with the architect and Building Inspector and, if he found that they were unable to properly perform their duties, he was to make such other appointments as he may be advised and to have them replaced by someone who would be more included to do this work.

There being no further business to come before the meeting, upon motion made by Councilman Mavon, the Council adjourned.
