

MINUTES OF THE SPECIAL MEETING
OF THE TOWN COUNCIL OF THE TOWN
OF GOLDEN BEACH, FLORIDA

July 11th, 1959

A Special Meeting of the Town Council of the Town Of Golden Beach, Florida was held on Saturday, July 11th, 1959 at 11:00 o'clock in the morning at the Town Hall. Upon roll call the following members were found to be present constituting a quorum of the Members of the Council.

Councilmen Mr. Philip H. Cummings and Mr. F. Waldo Roth, being out of Town were not able to be present at this meeting.

The meeting was called to order by the President, Mr. N. B. Ornitz, who acted as Chairman of this Meeting and Mrs. Laurita Chapman acted as Secretary.

The President, Mr. N. B. Ornitz, stated that the purpose of this Special Meeting was to discuss further the matter of the Metropolitan Court of Dade County taking over our traffic cases.

The Council President, Mr. N. B. Ornitz, stated that since the Town Council had adopted a Resolution that the functions of the Municipal Court of the Town of Golden Beach be retained as presently constituted until notice is received from Competent, Legal or Government Authority to change or amend such functions and that although such notice has not as yet been received, in order for the Town to maintain its present status in this regard, Resolution No. 83 had been prepared, which he would like to present to the Members of the Council for their approval and adoption, which Resolution, upon motion duly made, seconded and unanimously carried, was passed and adopted as follows:-

RESOLUTION NO. 83

WHEREAS, The Legislature of the State of Florida in the 1959 Session has adopted a Uniform Traffic Code for the State of Florida, being designated House Bill 715, Chapter 59-278 of the Session Law; and

WHEREAS said law prescribes certain violations and penalties therefor to be enforced in a uniform manner throughout the State of Florida; and *County of Dade.*

WHEREAS the Metropolitan Commission in and for the State of Florida, has adopted a Uniform Traffic Code, being Metropolitan Traffic Ordinance No. 57-12, governing moving Violations and the penalties therefor, within the boundaries of their jurisdiction; and

WHEREAS the Municipality of Golden Beach lies within the jurisdictional area of both of these governmental areas

NOW THEREFOR BE IT RESOLVED that the Town Council of the Town Of Golden Beach, Florida hereby adopts and declares as a part of the Town Of Golden Beach, Municipal Ordinances, the Uniform Traffic Code of the State of Florida and all of the Dade Metropolitan Uniform Traffic Code as shall not be inconsistent therewith.
