ORDINANCE NO. 404.95

AN ORDINANCE OF THE TOWN OF GOLDEN BEACH, FLORIDA, AMENDING CHAPTER 2, DIVISION 2 OF THE TOWN CODE TITLED, "CHARTER AND ORDINANCE REVIEW BOARD;" AMENDING THE COMPOSITION OF THE BOARD; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; PROVIDING FOR CODIFICATION; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. That Chapter 2, Division 2 of the Town Code of Ordinances is hereby amended to provide as follows:

"DIVISION 2. CHARTER AND ORDINANCE REVIEW BOARD

Sec. 2-62. Composition; chairman, meetings.

The Charter and Ordinance Review Board shall consist of the Mayor, a Councilmember selected by the Town Council, the Town Clerk, and three residents of the Town who are duly qualified electors, selected by the Mayor and confirmed by the Town Council. The Mayor shall act as Chairman of the Board which shall meet as the mayor may determine. The Town Clerk shall only vote in the event of a tie vote. The presence of the Town Clerk shall not be counted in determining a quorum.

Sec. 2-63. Terms of office.

The members of the Charter and Ordinance Review Board shall serve for periods of up to two years to run concurrently with the term of office of the Mayor, at which time their terms shall automatically terminate, unless reappointed.

Section 2. Conflict That all ordinances or parts of ordinances, all Town Code sections or parts of Town Code sections, and all resolutions or parts of resolutions in conflict with this Ordinance are hereby repealed to the extent of such conflict.

- Section 3. Severability Should any provisions of this Ordinance be declared by a court of competent jurisdiction to be invalid, the same shall not affect the validity of the ordinance as a whole, or any part thereof, other than the part declared to be invalid.
- Section 4. Codification. That a copy of this ordinance shall be furnished by the Town Clerk to the publisher of the Town Code to be codified in the next update of the Code.
- Section 5. Effective Date. That this Ordinance shall become effective immediately upon its adoption on second reading.
