

ORDINANCE NO. 405.95

AN ORDINANCE OF THE TOWN OF GOLDEN BEACH, FLORIDA, AMENDING CHAPTER 2, DIVISION 3 OF THE TOWN CODE TITLED, "BUILDING REGULATION ADVISORY BOARD," AMENDING THE COMPOSITION OF THE BOARD; PROVIDING FOR TERMS OF OFFICE FOR THE BOARD MEMBERS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; PROVIDING FOR CODIFICATION; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. That Chapter 2, Division 3 of the Town Code of Ordinances is hereby amended to provide as follows:

"DIVISION 3. BUILDING REGULATION AND ADVISORY BOARD

Sec. 2-76. Established, composition, term of office.

(a) A Building Regulation Advisory Board is hereby established which shall consist of:

(1) The Mayor (President of the Board).

~~(2) The Town Clerk.~~

~~(3)~~ (2) ~~Three~~ Four residents of the Town to be appointed by the Town Council.

(b) The Building Official and/or the Town Manager shall be present at all meetings.

(3) The four appointed members of the Building Regulation Advisory Board shall be residents of the town for two years preceding appointment, unless this requirement is waived by unanimous vote of the Town Council,

and shall serve for terms of three years expiring April first. The next appointments shall be for three years for two members, two years for one member and one year for one member, to stagger the terms. The members shall serve until their replacements are appointed.

Section 2. Conflict That all ordinances or parts of ordinances, all Town Code sections or parts of Town Code sections, and all resolutions or parts of resolutions in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 3. Severability Should any provisions of this Ordinance be declared by a court of competent jurisdiction to be invalid, the same shall not affect the validity of the ordinance as a whole, or any part thereof, other than the part declared to be invalid.

Section 4. Codification. That a copy of this ordinance shall be furnished by the Town Clerk to the publisher of the Town Code to be codified in the next update of the Code.

Section 5. Effective Date. That this Ordinance shall become effective immediately upon its adoption on second reading.




