AN ORDINANCE OF THE TOWN OF GOLDEN BEACH, FLORIDA, TO REGULATE AND RESTRICT THE ERECTION, RECONSTRUCTION, ALTERATION, LOCATION AND USE OF BUILDINGS: TO REGULATE AND RESTRICT BUILDINGS: TO REGULATE AND RESTRICT BUILDING LINES AND THE PERCENTAGE OF LOTS THAT MAY BE OCCUPIED AND THE DENSITY OF POPULATION, AND FOR SAID PURPOSES TO DIVIDE THE TOWN OF GOLDEN BEACH INTO ZONES, AND FOR EACH SAID ZONE TO IMPOSE REGULATIONS AND RESTRICTIONS UNDER WHICH BUILDINGS MAY BE PERMITTED TO PRESCRIBE PENALTIES FOR THE VIOLATION OF THE PROVISIONS OF THIS ORDINANCE, AND ALSO PROVIDE FOR ITS ENFORCEMENT.

WHEREAS, by the provisions of Chapter 14066, Laws of Florida, Acts of 1929, approved May 23, 1929, authority is conferred upon the Town of Golden Beach to designate and establish restricted residence districts within the Town, and to make such rules and regulations for the erection, reconstruction, altering and repairing of buildings of all kinds within said districts, as well as the use and occupancy of said buildings, and
