SECTION 1. In Zone Three (3), as designated by Zoning Ordinance No. 12, consisting of Blocks E, F, G, H, J, K, L, and M, no portion of any building shall be placed nearer than a point thirty-five feet distant from the waters of the Grand Canal, Lake Golden or Golden Isle Waterway.

SECTION 2.* No building shall be erected within the corporate limits of the Town of Golden Beach, except upon permit issued as heretefore provided by ordinance, and no permit for any building shall be issued if the same shall violate any of the provisions of this ordinance.
