sec. 4. Any person or persons, firm or corporation doing business as gardener, gardening contractor or landscape architect within the Town of Golden Beach who fails to secure a license for such business, shall, upon conviction in the Municipal Court, be liable to a fine of not less than \$5.00, nor more than \$50.00 a fine and imprisonment not exceeding ten days, or both such fine and imprisonment for each and every offense, in the discretion of the Municipal Judge.

Sec. 5. This Ordinance shall be declared to be an emergency measure and necessary for the protection and welfare of the inhabitants of the Town of Golden Beach, and shall take effect immediately upon its passage and approval by the Town Council.
