Any person or persons violating any of the provisions of this Ordinance, or failing, neglecting or refusing to comply with any of the provisions of this Ordinance, or in any manner interfering with, hindering or personance of any duty required by the provisions of this performance of any duty required by the provisions of this periodiance, shall, upon conviction in the municipal court, be liable to a fine of not was than Two hundred fifty dollars (\$250.00), or to be imprisoned in the Town jail for not exceeding ten (10) days, or both such fine and imprisonment for each and every offense, at the discretion of the Municipal Judge.
