RESOLUTION NO. 1007.96

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH FLORIDA, FLORIDA; APPROVING AN AGREEMENT BETWEEN THE TOWN OF GOLDEN BEACH AND SHARK WRECKING, CORP. FOR THE DEMOLITION OF THE ILLEGAL STRUCTURE LOCATED AT 326 OCEAN DRIVE, GOLDEN BEACH, FLORIDA; AUTHORIZING AN AGREEMENT FOR THE RELOCATION OF ELECTRIC UTILITY SERVICE; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING AN EFFECTIVE DATE.

BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA AS FOLLOWS:

Section 1. That the Agreement between the Town of Golden Beach and Shark Wrecking Corp., substantially in the form as attached to this Resolution as Exhibit A, is hereby approved. The appropriate town officials are authorized and directed to execute the Agreement.

Section 2. That the Town Manager and Police Chief are authorized to designate police officers on duty or off duty to assist as provided in the Agreement.

Section 3. That the Town Manager or her designee is authorized to enter into an agreement with Interior Electric, Inc. to relocate the electric utility service at 326 Ocean Drive from the illegal structure to the pre-existing occupied house, in an amount not to exceed \$5,985.00.

Section 4. Severability. Should any provisions of this Resolution be declared by a court of competent jurisdiction to be invalid, the same shall not affect the validity of the Resolution as a whole, or any part thereof, other than the part declared to be invalid.


Section 5. Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 6. Effective Date. That this Resolution shall become effective upon approval of the Town Council.


