RESOLUTION NO. 912.94 OF THE TOWN COUNCIL OF
THE TOWN OF GOLDEN BEACH, FLORIDA
ESTABLISHING AN AD HOC ADVISORY COMMITTEE TO
ADVISE THE COUNCIL OF RECOMMENDATIONS TO
COMPLY WITH THE AMERICANS WITH DISABILITIES
ACT (ADA); PROVIDING AN EFFECTIVE DATE

WHEREAS, the Golden Beach Town Council desires to implement a plan to ensure that the town complies with the Americans with Disabilities Act of 1990(ADA), the Rehabilitation Act of 1973, as amended, Chapter 553 of Florida Statutes and all other local, State and federal directives, ordinances, rules, orders and laws relating to people with disabilities, and

WHEREAS, the Town Council wishes to appoint an ad hoc advisory committee of people with disabilities, parents of children with disabilities, and advocates of people with disabilities, to advise and assist them with the implementation of a plan for structural renovations, program access, and issues that need to be addressed on an ongoing basis.

NOW THEREFORE BE RESOLVED BY THE TOWN COUNCIL OF GOLDEN

BEACH:

Section 1. That the Town Council hereby establishes an ad hoc committee of no less than three nor more than five members, who shall be residents of the town, appointed by the Town Council.

Section 2. That the members of the committee shall serve for a period to run concurrently with the term of office of the Mayor, however, they shall serve until their successors are appointed.

Section 3. That the committee shall review the ADA Compliance Survey and Implementation Plan which was prepared for the town on July 27, 1994 and recommend criteria which can be used to determine priorities for structural renovations, and advise the council on this issue, program access issues, and problems which need to be addressed on an ongoing basis to ensure ADA compliance.

Section 4. Effective Date. That this Resolution shall become effective upon approval of the Town Council.
