RESOLUTION NO. 921.95 OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA CALLING FOR A GENERAL ELECTION PURSUANT TO CHAPTER 6 OF THE CHARTER OF THE TOWN OF GOLDEN BEACH ON THE 21ST DAY OF FEBRUARY, 1995; ESTABLISHING A FILING FEE AT \$50.00; PROVIDING FOR THE CLOSING OF REGISTRATION BOOKS; ADOPTING DESIGNATION OF POLLING PLACE, NAMES OF CLERKS AND INSPECTORS; FORM OF BALLOT AND NOTICE OF ELECTION IN ACCORDANCE WITH THE REQUIREMENTS OF METROPOLITAN DADE COUNTY AND THE LAWS OF THE STATE OF FLORIDA; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Chapter 6 of the Charter of the Town of Golden Beach requires a General Election to be held on the 21st day of February, 1995, (the third Thursday in February, odd numbered years) for the purpose of electing members of the Council (including the Mayor), and

WHEREAS, the Charter provides that the filing fee for candidates for the office of Council shall be no less than \$50.00, and

WHEREAS, Metropolitan Dade County has established the polling place, names of clerks and inspectors, form of ballot and Notice of Election.

NOW THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH:

Section 1. That a General Election for the office of Council be and the same is hereby called pursuant to Chapter 6 of the Charter of the Town of Golden Beach to be held in Golden Beach on the 21st day of February, 1995.

Section 2. That a filing fee for candidates seeking to qualify for said election shall be \$50.00.

Section 3. That the said election shall be held in the Town Hall. Names of clerks, inspectors and the form of ballot shall be in accordance with the provisions of Metropolitan Dade County supervisor of elections and the laws of the State of Florida.

Section 4. Registration books shall be closed on the 23rd day of January, 1995. All persons qualified to vote in elections held within the Town of Golden Beach may register therefore until the books of registration shall be closed on said date as required by election laws of the State of Florida; and the Code of Ordinances of Metropolitan Dade County.

Section 5. The nomination filing period shall be closed on the 9th day of January, 1995, at 12:00 Noon in Town Hall. All nominating petitions must be filed with the Town Clerk no later than 12:00 Noon, January 9, 1995.
