RESOLUTION NO. 955.95**

**A RESOLUTION OF THE MAYOR AND TOWN COUNCIL
OF THE TOWN OF GOLDEN BEACH ADOPTING THE
FINAL MILLAGE RATE OF THE TOWN OF GOLDEN
BEACH FOR THE FISCAL YEAR COMMENCING
OCTOBER 1, 1995 AND ENDING SEPTEMBER 30, 1996
PURSUANT TO FLORIDA STATUTE SECTION 200.065
(TRIM BILL); AUTHORIZING TOWN CLERK TO FORWARD
COPIES OF THIS RESOLUTION TO THE APPROPRIATE
GOVERNMENTAL AGENCIES; AND PROVIDING AN
EFFECTIVE DATE.**

**WHEREAS, on September 12, 1995, the Mayor and Town Council passed and
adopted Resolution No. 953.95 setting the tentative millage rate for the Town of
Golden Beach, and**

**WHEREAS, the Town has properly noticed the second public hearing
scheduled for September 12, 1995, at 7:30 P.M. in the Council Chambers of the
Town Hall located at One Golden Beach Drive, Golden Beach, Florida; and**

**WHEREAS, the said second public hearing was held as noticed and the public
and all interested parties having had an opportunity to address their comments to
the Town Council and having complied with the "TRIM" requirements of the Florida
Statutes;**

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL
OF THE TOWN OF GOLDEN BEACH, FLORIDA AS FOLLOWS:**

**Section 1. That the tentative millage as presented by the Mayor and Town
Manager for the fiscal year commencing October 1, 1995 and ending September 30,
1996 be and is hereby fixed at the rate of 8.7377 mills which is \$8.7377 dollars per
one thousand dollars of assessed property value within the Town of Golden Beach.**

RESOLUTION NO. 955.95

Section 2. That the "rolled back rate" for the Town of Golden Beach is 8.4401 per thousand and that the millage rate of 8.7377 is 3.53% above the "rolled back rate".

Section 3. That the Town Clerk is hereby authorized and directed to forward copies of this Resolution to the appropriate governmental agencies.

Section 4. That this resolution shall become effective upon approval of the Town Council.

The Motion to adopt the foregoing Resolution was offered by COUNCILMAN ROSENTHAL, seconded by VICE MAYOR LOWRANCE and on roll call the following vote ensued:


