INFORMED AS TO THE OBJECTIVES OF THE
GOVERNMENT OF GOLDEN BEACH; AND PROVIDING
AN EFFECTIVE DATE.**

**BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH,
FLORIDA:**

**Section 1. That pursuant to Section 3.05 of the Town Charter the
Councilmembers listed below are hereby assigned the duty to inquire into the
operation of a particular area of governmental responsibility relating to the Town
of Golden Beach in order to become informed as to the objectives of the Town
Government. This assignment shall remain in affect until March 19, 1996 (regular
Council meeting) unless amended by resolution or motion of the Town Council.**

**Section 2. That the various areas of Town Government are Parks and
Recreation, Beautification, Law and Finance, Police, and Public Works and are
hereby assigned as follows:**

Kerry E. Rosenthal	Law and Finance
Judy Cuenca	Beautification
Charles Fistel	Public Works
Michael Addicott	Parks and Recreation
Lisa Lowrance	Police

**Section 3. This assignment shall be effective until Tuesday, March 19,
1996, unless extended by motion or resolution of the Town Council.**

**Section 4. Effective Date. That this Resolution shall become effective
upon approval of the Town Council.**
