**RESOLUTION NO. 1830.06**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AUTHORIZING PURCHASE OF ONE (1) PUBLIC WORKS VEHICLE FOR THE GOLDEN BEACH PUBLIC WORKS DEPARTMENT; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Town Council of the Town of Golden Beach, Florida (the "Town") wishes to acquire one (1) 2007 Ford F-250 4-wheel drive four door pick-up truck (the "Vehicle") as described and outlined in the attached Agenda Item Report; and

**WHEREAS**, in accordance with the Town's purchasing procedures, the Vehicle shall be obtained from or through the Florida Sheriffs Association, Florida Association of Counties, & Florida Fire Chiefs Association 13<sup>th</sup> Annual Cooperative Bid for Pursuit, Administrative Non-pursuit, Utility Vehicles, Trucks & Vans, and Other Fleet Equipment from advertised bid lists or procedures adopted by competitive bidding; and

**WHEREAS**, the Town Council finds that the purchase of this Vehicle is in the best interest of the Town.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals Adopted.** That each of the above-stated recitals is hereby adopted and confirmed.

**Section 2. Authorization of Purchase.** The expenditure of funds in an amount not more than \$25, 547.00 for the purchase of one (1) 2007 Ford F-250 4-wheel drive four door vehicle, as described and outlined in the Agenda Item Report attached and incorporated herein, is hereby authorized and approved.


