## **ORDINANCE NO. <u>564.15</u>**

AN ORDINANCE OF THE TOWN OF GOLDEN BEACH. FLORIDA. **AMENDING** CHAPTER 66, "ZONING." ARTICLE "SUPPLEMENTARY DISTRICT **REGULATIONS."** DIVISION "GENERALLY," 1 DELETE THE INSPECTION AND ENFORCEMENT FEE RENTAL OCCUPATIONAL **LICENSES** AUTHORIZE SAID FEE TO BE SET BY RESOLUTION OF THE TOWN COUNCIL: **PROVIDING** IMPLEMENTATION: PROVIDING FOR SEVERABILITY: PROVIDING FOR CONFLICTS AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town Council of the Town of Golden Beach ("Town Council") finds it periodically necessary to amend its Code of Ordinances ("Code") in order to update regulations and procedures to implement municipal goals and objectives; and

WHEREAS, Chapter 66, "Zoning," Article IV "Supplementary District Regulations," Division 1 "Generally," of the Code provides a process and a fee for inspection and enforcement for a rental occupational license; and

WHEREAS, the Town Council desires to delete the specific fee from the Town Code and provide for the subsequent adoption of the inspection and enforcement fee by resolution of the Town Council; and

WHEREAS, the Town Council, meeting as the Local Planning Agency, considered the amendments proposed in this Ordinance on March 17<sup>th</sup>, 2015 and recommended adoption of this Ordinance to the Town Council; and

WHEREAS, after careful consideration of this matter, the Town Council has determined that it is in the best interests of the Town to approve the text amendments to Chapter 66, Zoning.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals Adopted.</u> Each of the above stated recitals are hereby adopted, confirmed and incorporated herein.

<u>Section 2.</u> <u>Amendment.</u> Chapter 66 of the Town Code is amended by making modifications to Division 1, Generally, of Article IV, Supplementary District Regulations, in the following particulars:

ARTICLE IV. Supplementary District Regulations.

**DIVISION 1. Generally.** 

Sec. 66-91. - Transient use of a residential dwelling prohibited.

\* \* \*

(f) Fees; Application Schedule. A person or entity who holds a rental occupational license shall pay an inspection and enforcement fee as established by resolution of the Town Council. of \$125.00 upon the filing of each rental application. The fee is based upon a calendar year.

\* \* \*

<u>Section 3.</u> <u>Implementation.</u> The Town Clerk and Town Manager are hereby authorized to take any and all action necessary to implement this Ordinance and make it part of the Town Code including re-numbering or re-lettering the code references and ordering.

<u>Section 4.</u> <u>Severability.</u> If any section, part of section, paragraph, clause, phrase or word of this Ordinance is declared invalid, the remaining provisions of this Ordinance shall not be affected.

<u>Section 5.</u> <u>Conflicts.</u> To the extent that this Ordinance conflicts wholly or partially with any existing provision in the Town Code, the terms of this Ordinance shall prevail.

<u>Section 6.</u> <u>Effective Date.</u> This Ordinance shall be effective immediately upon adoption.
