WHEREAS, said public hearing, as required by Section 200.065(2)(c), was held by the Town Council on September 9, 2014, commencing at 7:00 p.m., as previously noticed and the public and all interested parties having had the opportunity to address their comments to the Town Council and the Town Council having considered the comments of the public regarding the proposed millage rate and having complied with the "TRIM" requirements of the Florida Statutes.the Town Council approved a proposed millage rate of 7.2450 mills: and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE TOWN OF **GOLDEN BEACH, FLORIDA AS FOLLOWS:**

That the final millage rate for the Town of Golden Beach for the fiscal year commencing October 1, 2014 through September 30, 2015, be and is hereby fixed at the rate of 7.2450 mills which is \$ 7.2450 dollars per \$1,000.00 of assessed property value within the Town of Golden Beach.
