A RESOLUTION OF THE TOWN OF GOLDEN BEACH, FLORIDA, AUTHORIZING AND APPROVING A VARIANCE REQUEST FOR THE PROPERTY LOCATED AT 484 NORTH PARKWAY, GOLDEN BEACH, FLORIDA 33160 TO PERMIT A DOCK TO EXTEND OUT INTO THE WATERWAY AT 10.41', WHERE 6' IS ALLOWED

WHEREAS, the applicants, The Coral Gables Trust, as Trustees of the Platano FL Exempt Trust, (the applicants"), filed a Petition for a Variance/exception, Article IV – Seawall and Docks: Section 46-84 General specifications for docks, to permit a dock to extend into the waterway at approximately 10.41', in lieu of the Town Codes requirement of 6', at 484 North Parkway, Golden Beach, Florida 33160 (Golden Beach Section "E", Lot 30 & E 25' of Lot 29, Block F, as recorded in PB 8-122, of the Public Records of Miami-Dade County, (Folio No. 19-1235-005-0380 (the "Property") and ;

WHEREAS, the Town's Building Regulation Advisory Board held an advertised public hearing on the Petition for Variance/Exception and recommended approval of the variance by the Town Council; and,

WHEREAS, a public hearing of the Town Council was advertised and held, as required by law, and all interested parties were given an opportunity to be heard; and
