A RESOLUTION OF THE TOWN OF GOLDEN BEACH, FLORIDA, AUTHORIZING AND APPROVING ADDITIONAL WORK PURSUANT TO THE AGREEMENT BETWEEN THE TOWN OF GOLDEN BEACH AND IRON SKY, INC. FOR AN INTEGRATED CCTV SECURITY CAMERA SYSTEM AND WIRELESS DATA NETWORK; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on March 27, 2012, the Town Council of the Town of Golden Beach (the "Town"), pursuant to Resolution No. 2231.12, approved an Agreement with Iron Sky, Inc. ("Iron Sky") for an integrated closed-circuit television (CCTV) security camera system and/or wireless data network ("Security Camera System") for the Town (the Agreement"); and

WHEREAS, the Town and Iron Sky wish to amend the Agreement to include additional work (the "Additional Work") as described in the proposals attached hereto as Exhibit "A" to this Resolution (collectively, the "Proposal"); and

WHEREAS, Iron Sky has agreed to perform the Additional Work; and

WHEREAS, the cost of the Additional Work shall be paid by the Town as set forth in the Proposal; and

WHEREAS, the Town Council has determined that it is in the best interests of the Town to approved the Additional Work, as set forth in the Proposal.
