That the Town Council hereby appoints Dina Nicolella, Alene Fishbein, Judy Lusskin, Ellen Sprechman, Linda Kropp, Ana Garcia, Jennifer Kay, Inger Skroder, June Krogoll and Cathy Szabo to serve as members of the Committee for an initial term of one year through December 2008, allowing for re-appointment.

<u>Section 3.</u> <u>Implementation.</u> That the Mayor and Town Manager are authorized to take any and all action which is necessary to implement this Resolution.

<u>Section 4.</u> <u>Effective Date.</u> That this Resolution shall be effective immediately upon adoption.
