Lipton, and Mr. Alex Hockman to serve as alternate members of the Board for another term of one year through December 2008, allowing for re-appointment.

Section 3. Implementation. That the Mayor and Town Manager are authorized to take any and all action which is necessary to implement this Resolution.

Section 4. Effective Date. That this Resolution shall be effective immediately upon adoption.
