A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AUTHORIZING THE USE OF FORFEITED ASSETS FOR THE PURCHASE OF SIX (6) RECONDITIONED MOBILE POLICE RADIOS AND EIGHT (8) RECONDITIONED PORTABLE POLCE RADIOS, PROVIDING FOR IMPLEMENTATION; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town 's Police Department needs to purchase an additional six (6) 800 MHz mobile radios and eight (8) Portable 800 MHz radios to provide adequate radio coverage for the Town; and

WHEREAS, in accordance with the Town's purchasing procedures, the Mayor / Town Manager will purchase these items; and

WHEREAS, the Town Council finds that the utilization of \$9,900 of the forfeited assets for the purchase of these items is in the best interest of the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

The expenditure of Law Enforcement Trust Fund (LETF) and / or Federally Forfeited Asset funds in an amount not more than \$9,900.00 for the purchase and implementation of these items, as described and outlined in the Agenda Item Report attached and incorporated herein, is hereby authorized and approved.
