Section 1. Recitals Adopted. That each of the recitals stated above is hereby adopted and confirmed.

Section 2. Agreement Approved. That certain Town of Golden Beach Agreement for Professional Services in substantially the form attached hereto as Exhibit "A"(the "Agreement"), is hereby approved, and the Mayor is authorized to execute the Agreement on behalf of the Town, once approved by the Town Attorney as to form and legal sufficiency.

<u>Section 3.</u> <u>Implementation.</u> That the Mayor and Town Manager are hereby authorized to take any necessary action to implement the Agreement and this Resolution in accordance with the terms and conditions of this Resolution and the Agreement.

<u>Section 4.</u> <u>Effective Date.</u> That this Resolution shall be effective immediately upon adoption hereof.
