RESOLUTION NO. <u>1922.08</u>

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AWARDING THE PUBLIC WORKS BUILDING RENOVATION PROJECT TO BEJAR CONSTRUCTION, INC.; AUTHORIZING THE TOWN MAYOR AND TOWN MANAGER TO NEGOTIATE AND ENTER INTO A CONTRACT WITH BEJAR CONSTRUCTION, INC. IN AN AMOUNT NOT TO EXCEED \$43,600; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE;

WHEREAS, the Town of Golden Beach (the "Town") pursuant to a Request For Proposal/Qualifications RFP No. 2008-003 (the "RFP") solicited bids for certain renovations to the Town's Public Works Building (the "Renovation Project"), and;

WHEREAS, the Town received multiple bids in response to the RFP; and,

WHEREAS, the submitted bids have been evaluated in accordance with the appropriate review criteria; and,

WHEREAS, the evaluation of the bids has resulted in a recommendation that the Renovation Project be awarded to Bejar Construction, Inc., (the "Contractor") as set forth in the attached Memorandum accompanying this Resolution as Exhibit "A"; and,

WHEREAS, the Town Council has accepted the recommendation to award the Renovation Project to the Contractor; and,

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals Adopted.</u> Each of the above stated recitals are hereby adopted, confirmed and incorporated herein.

<u>Section 2.</u> Award. The Contractor is hereby awarded the Renovation Project subject to the execution of a contract as provided for in Section 3 below.

<u>Section 3.</u> <u>Contract.</u> The Town Mayor is hereby authorized to negotiate and enter into a contract with the Contractor which incorporates the terms of the Contractor's bid attached as Exhibit "B" to this Resolution and which contract shall be in form and content of the type generally used by the Town for construction services. Said contract shall not exceed \$43,600.

<u>Section 4.</u> <u>Implementation.</u> The Mayor and Town Manager are hereby authorized to take all necessary steps to implement this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall be effective immediately upon adoption.
