A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AFFIRMING THE PRE-QUALIFIED FIRMS FOR THE CAPITAL IMPROVEMENT PROGRAM PROJECT; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Golden Beach (the "Town") pursuant to a Request For Competitive Proposals for the Town of Golden Beach Capital Improvement Program RFCP Project # 734-01 (the "RFCP") requested prospective proposers to submit their qualifications to the Town; and;

WHEREAS, the Town received multiple submissions concerning qualifications of prospective proposers in response to this first stage of the RFCP; and,

WHEREAS, the submitted qualifications have been evaluated in accordance with the appropriate review criteria; and,

WHEREAS, the evaluation of the qualifications has resulted in a recommendation of the top ranked five firms to be the pre-qualified firms and the 6th and 7th firms to be the alternates, as set forth in the attached Memorandum accompanying this Resolution as Exhibit "A"; and,

WHEREAS, the Town Council has accepted the recommendation as to the prequalified firms.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals Adopted.</u> Each of the above stated recitals are hereby adopted, confirmed and incorporated herein.

Section 2. Affirmation. The top ranked five firms are hereby affirmed as the pre-qualified firms and the 6th and 7th as alternates for the RFCP, as set forth in the Memorandum, attached as Exhibit "A".

Section 3. Authorization. The Town Mayor is hereby authorized to allow the two alternate firms to participate in the bidding process if deemed to be necessary.

The Mayor and Town Manager are hereby Section 4. Implementation. authorized to take all necessary steps to implement this Resolution.

Effective Date. This Resolution shall be effective immediately Section 5. upon adoption.
