TOWN GOLDEN BEACH, FLORIDA RESOLUTION NO. 1932.08

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AUTHORIZING THE TOWN MANAGER TO ALLOCATE UP TO A TOTAL OF FIFTY THOUSAND DOLLARS (\$50,000) FROM THE TOWN HALL/PAVILION RENOVATION BUDGET, FOR THE PURCHASE OF THE FURNITURE AND OTHER ITEMS LISTED ON EXHIBIT "A" TO THIS RESOLUTION IN LIEU OF THE ITEMS LISTED ON EXHIBIT "A" TO RESOLUTION NO. 1896.08; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town Council of the Town of Golden Beach, Florida authorized the renovation of the Beach Pavilion (Resolution No. 1871.07); and

WHEREAS, the Town Council adopted Resolution No. 1896.08 on January 15, 2008, authorizing the Town Manager to allocate up to Fifty Thousand Dollars (\$50,000) from the Town Hall / Pavilion Renovation budget for the purchase of certain items more particularly described on Exhibit "A" to Resolution No. 1896.08; and

WHEREAS, the Town Manager has recommended certain changes to the items listed on Exhibit "A" to Resolution No. 1896.08; and

WHEREAS, the Town Council finds that purchasing the items listed on Exhibit "A" to this Resolution in lieu of the items listed on Exhibit "A" to Resolution No. 1896.08, including, without limitation, the lounge chairs, beach dinning-chairs, picnic tables, trash receptacles, minor-landscaping and other furnishings, is in the best interest of the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1 Recitals Adopted. That each of the above-stated recitals is hereby adopted and confirmed.

Section 2 Authorization. That the Town Council hereby approves the expenditure of up to \$50,000 for the purchase of the items listed on Exhibit "A" to this Resolution in lieu of the purchase of the items listed on Exhibit "A" to Resolution No. 1896.08, subject to the purchasing provisions of the Town Code of Ordinances.

<u>Section 3</u> <u>Implementation.</u> That the Mayor and Town Manager are authorized to take any and all action which is necessary to implement this Resolution.

Section 4 Effective Date. That this Resolution shall be effective immediately upon approval of the Town Council.
