A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, DETERMINING THE DETERMINING PROPOSED MILLAGE RATE: CURRENT YEAR ROLLED-BACK RATE; ESTABLISHING THE DATE. TIME AND PLACE FOR THE FIRST AND SECOND PUBLIC BUDGET HEARINGS AS REQUIRED BY TO FILE LAW: DIRECTING THE CLERK RESOLUTION WITH THE PROPERTY APPRAISER OF **PURSUANT** TO THE COUNTY MIAMI-DADE REQUIREMENTS OF FLORIDA STATUTES AND THE RULES AND REGULATIONS OF THE DEPARTMENT OF REVENUE OF THE STATE OF FLORIDA; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on July 1, 2008, the Honorable Marcus Saiz de la Mora, The Property Appraiser of Miami-Dade County, Florida, served upon the Town of Golden Beach (the "Town"), a "Certification of Taxable Value" certifying to the Town its 2008 taxable value; and

WHEREAS, the provisions of Section 200.065, Florida Statutes, require that within thirty-five (35) days of service of the Certification of Taxable Value upon a municipality, said municipality shall be required to furnish to the Property Appraiser of Miami-Dade County the proposed millage rate, the current year rolled-back rate, and the date, time, and place at which a first public hearing will be held to consider the proposed millage and the tentative budget; and

WHEREAS, the Town Council desires to announce the dates of the first and second public hearings to the Property Appraiser of Miami-Dade County; and

WHEREAS, the Town Council has reviewed the figures supplied by the Property

Appraiser of Miami-Dade County and conferred at a public meeting with the Town

Attorney and that being otherwise fully advised in the premises.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. Recitals Adopted. That each of the above stated recitals is hereby adopted and confirmed.

Section 2. That the proposed Millage Rate for the first public hearing shall be 7.605 mills, which is 7.605 per \$1,000.00 of assessed property within the Town of Golden Beach for the 2008/2009 fiscal year.

Section 3. That the proposed Voted Millage Rate is **1.395**.

Section 4. That the current year rolled-back rate, computed pursuant to 200.065 Florida Statutes, is 8.233 per \$1,000.00.

Section 5. That the date, time and place of the first and second public hearings are hereby set by the Town Council as follows:

<u>Section 5.</u> That pursuant to the Florida Statutes, and the rules and regulations of the Florida Department of Revenue, the Town Clerk is herby directed to attach the original Certification of Taxable Value to a certified copy of this resolution and serve the same upon the Honorable Marcus Saiz de la Mora, Property Appraiser of Miami-Dade

County, before August 3, 2007.

<u>Section 6.</u> <u>Effective Date.</u> That this Resolution shall be effective immediately upon adoption.
