A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AUTHORIZING THE TOWN MANAGER TO SUBMIT A FLORIDA CITY OF EXCELLENCE AWARD NOMINATION TO THE FLORIDA LEAGUE OF CITIES UNDER THEIR 2008 FLORIDA CITIES OF EXCELLENCE AWARDS PROGRAM; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Florida League of Cities has established its 2008 Florida Cities of Excellence Awards Program to acknowledge the many services cities and city employees contribute to the quality of life in Florida ; and

WHEREAS, the Town Council of the Town of Golden Beach is proposing to submit an award nomination under the Florida City of Excellence Award category to recognize the Town of Golden Beach's outstanding leadership, citizen outreach, technology, fiscal management and innovative programs; and

WHEREAS, the Town of Golden Beach desires to authorize the submission of a Florida City of Excellence Award nomination to the Florida League of Cities 2008 Florida City of Excellence Awards Program.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. Recitals Adopted. That each of the above-stated recitals is hereby adopted and confirmed.

Section 2. Implementation. The Mayor and Town Manager of the Town of Golden Beach are hereby authorized to submit a Florida City of Excellence Award

nomination to the Florida League of Cities under the 2008 Florida City of Excellence Awards Program.
