RESOLUTION NO. 1952.08

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, FINDING THAT CERTAIN PERSONAL PROPERTY IS UNUSABLE AND SURPLUS; AUTHORIZING THE SALE OF SAID PROPERTY; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, the Town is the owner of the personal property listed on Exhibit "A" to the Resolution (the "Property"); and

**WHEREAS**, the respective Town Department heads have determined (with the concurrence of the Town Manager) that the Property is unusable and surplus; and

**WHEREAS**, the Town Council finds that the Property has some value and should be sold at auction.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:**

**Section 1.** **Recitals Adopted.** That each of the above-stated recitals is hereby adopted and confirmed.

**Section 2.** **Authorization To Sell.** The Property is hereby declared unusable and surplus for the Town's needs and it should be sold at auction to retrieve its greatest value.

**Section 3.** **Implementation.** That the Mayor and Town Manager are authorized to take any and all action which is necessary to implement this Resolution.

**Section 4.** **Effective Date.** That this Resolution shall be effective immediately upon adoption.


