A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, APPROVING A BUDGET TRANSFER FROM UNDESIGNATED FUND RESERVES TO THE NEWLY CREATED FUND 340 (BRIDGE MAINTENANCE AND REPLACEMENT FUND) FOR FISCAL YEAR OPERATING BUDGET 2008-2009; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town Council of the Town of Golden Beach, Florida (the "Town") adopted an Operating Budget for the 2008-2009 Fiscal Year; and

### Recommendation:

It is recommended that the Town Council adopt the attached Resolution No. 1968.08 as presented.

### **Background:**

By your action we have created Fund 340 the Bridge Maintenance and Replacement Fund. Since learning of the Town's deficient bridge needs, I have been working with the Mayor to identify the needed resources to adequately meet our funding needs which are currently estimated at \$5-million dollars per bridge (Center Island and Navona Avenue).

I propose that we allocate \$1.3 million from the Town's reserves to meet this unfunded request.
