A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AUTHORIZING THE ACCEPTANCE OF A DONATION OF FOUR PROTECTIVE VESTS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Florida Police Defense Foundation Special Projects Division and the Point Blank Protective Body Amour Corporation are working together to donate protective vests for K-9 police officers as well as the K-9s. The K-9 vest is a Level 2 "Spike" for the K-9, and a level 3 is a call out vest for the officer; and

WHEREAS, these protective vests are the newest technology on the market today and if the Town were to purchase them, the cost to the Town would be approximately \$3,800.00; and

WHEREAS, the Town Council of the Town of Golden Beach, Florida (the "Town") wishes to accept the donation of four protective vests for the Police K-9 Unit for the purposes of assisting in the protection of the Police Department's K-9 officers and dogs, as described and outlined in the attached Agenda Item Report; and

WHEREAS, the Town Council finds that acceptance of the donation of these protective vests is in the best interest of the Town in protecting its law enforcement officers and K-9s.

It is recommended that the Town Council adopt the attached Resolution No. 2025.09 as presented.

Background:

Officer Leila Miles was contacted by an acquaintance, Commander Michael Calderon of the Broward Sheriffs Office and he is the State Administrator for the Florida Police Defense Foundation Special Projects Division program. He contacted her to learn if Golden beach could use protective vests for the K-9 Unit. Officer Miles referred him to A/Sgt. Lyndean Peters of the GBPD K-9 Unit. Acting Sergeant Peters then met with Commander Calderon in Coral Springs and the Officers and K-9s were measured

The Defense Foundation will hold a news conference on the morning of August 25th to help make the public aware of the Foundation and to help promote the drive. The Foundation is also giving away vests to Coral Springs Police Department and to a Broward Sheriff's Office Deputy. The Florida Police defense Foundation Special Projects Division is donating vest's for Handlers as well as the K-9's. Point Blank is assisting the Foundation in this endeavor. The K9 vest is a Level 2 "Spike" for the dog and a level 3 in a call out vest for the handler. If the Town were to buy them the vests, the cost would be approximately \$3,800.00. The vests are the newest technology on the market today. The Foundation's goal is to supply the entire state of Florida with vests for all Police K-9 Units.
