RESOLUTION NO. 2037.09

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA; APPOINTING MEMBERS TO THE TOWN OF GOLDEN BEACH RECREATION ADVISORY COMMITTEE PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on January 17, 2006, the Town Council of the Town of Golden Beach adopted Ordinance No. 502.06, codifying the establishment of the Recreation Advisory Committee (the "Committee"); and

WHEREAS, the Town Council appointed Dina Nicolella, Alene Fishbein, Vice Mayor Judy Lusskin, Ellen Sprechman, Linda Kropp, Ana Garcia, Jennifer Kay, Inger Skroder and June Krogoll to serve as members of the Committee for one-year terms, which have now expired; and

WHEREAS, the Town Council wishes to make new appointments to the committee.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

**Section 1. Recitals Adopted.** That the foregoing recitals are true and correct and incorporated herein by this reference.

**Section 2. Appointment and Term.** That the Town Council hereby appoints Dina Nicolella, Alene Fishbein, Vice Mayor Judy Lusskin, Ellen Sprechman, Linda Kropp, Jennifer Kay, June Krogoll, Cathy Szabo and Navreen Syed to serve as members of the Committee for an initial term of one year beginning on September 22, 2009.

**Section 3. Implementation.** That the Mayor and Town Manager are authorized to take any and all action which is necessary to implement this Resolution.

**Section 4. Effective Date.** That this Resolution shall be effective immediately upon adoption.
