Section 2. Appointment and Term. That the Town Council hereby appoints Leon Egozi, Lydia Eskenazi, Jack Barough, Vice Mayor Lusskin, Jerome Hollo and Fred Chouinard to serve as members of the Committee, and Robert Smoley to serve as an alternate member of the Committee for an initial term of one year beginning on September 22, 2009.

That the Mayor and Town Manager are Implementation. Section 3. authorized to take any and all action which is necessary to implement this Resolution.

Effective Date. That this Resolution shall be effective immediately Section 4. upon adoption.
