RESOLUTION NO. 2042.09

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA ADOPTING THE FINAL MILLAGE RATE OF THE TOWN OF GOLDEN BEACH FOR THE FISCAL YEAR COMMENCING OCTOBER 1, 2009 THROUGH SEPTEMBER 30, 2010 PURSUANT TO FLORIDA STATUTE 200.065 (TRIM BILL); PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on July 31, 2009, the Town transmitted to the Property Appraiser its "Proposed Millage Rate" for the fiscal year commencing October 1, 2009 and further scheduled the public hearing required by Section 200.065 of the Florida Statutes to be held on September 16, 2009 at 7:00 p.m.; and

WHEREAS, the Property Appraiser properly noticed the public hearing scheduled for September 16, 2009 at 7:00 p.m. at One Golden Beach Drive, Golden Beach, Florida, as required by Chapter 200 of the Florida Statutes; and

WHEREAS, said public hearing, as required by Section 200.065(2)(c), was held by the Town Council on September 16, 2009, commencing at 7:00 p.m., as previously noticed, and the public and all interested parties having had the opportunity to address their comments to the Town Council and the Town Council having considered the comments of the public regarding the proposed millage rate and having complied with the "TRIM" requirements of the Florida Statutes, the Town Council approved a proposed millage rate of 7.1525 mills; and

WHEREAS, as required by Section 200.065(2)(c) a second public hearing was held by the Town Council on September 22, 2009, commencing at 7:30 p.m., as previously noticed, and the public and all interested parties had the opportunity to address their comments to the Town Council and the Town Council considered the comments of the public regarding the final millage rate and complied with the "TRIM" requirements of the Florida Statutes.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA AS FOLLOWS:

Section 1. That the final millage rate for the Town of Golden Beach for the fiscal year commencing October 1, 2009 through September 30, 2010, be and is hereby fixed at the rate of 7.1525 mills which is \$7.1525 dollars per \$1,000.00 of assessed property value within the Town of Golden Beach.

Section 2. That the rolled-back rate is 7.7154 and the proposed millage rate is 7.1525 mills which is 7.2958 % under the rolled-back rate.

Section 3. That the voted millage for the fiscal year will be 1.3475 mills.

Section 4. That this resolution shall be effective immediately upon adoption.


