RESOLUTION NO. 2056.09

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, RENAMING THE PARK COMMONLY KNOWN AS ROCK PARK TO GLENN SINGER PARK; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Council of the Town of Golden Beach (the "Council") desires to rename the Town park commonly known as "Rock Park" as "Glenn H. Singer Park"; and

WHEREAS, the Town Council desires to rename and designate the park as the "Glenn Singer Park," in honor of the Town's long-time resident and mayor and his service to the Town; and

WHEREAS, the Town Council finds that it is in the best interests of the Town to rename and designate the park as the "Glenn Singer Park."

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. Recitals Adopted. That each of the above stated recitals are hereby adopted, confirmed and incorporated herein.

Section 2. Renaming of Park Authorized. In recognition of the outstanding dedication and service rendered by Glenn Singer to the residents of the Town of Golden Beach, the Council formally renames and designates the Town park commonly known as "Rock Park" as "Glenn Singer Park", in perpetuity and in honor of Mayor Glenn Singer.

Section 3. Implementation. The Town Manager is hereby authorized to take any and all action necessary to designate and implement the park as "Glenn Singer

Park” or “Singer Park” where appropriate, and to implement this Resolution in accordance with its terms and purposes.

Section 4. Effective Date. That this Resolution shall be effective immediately upon adoption.
