## **RESOLUTION NO. 2115.10**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN GOLDEN BEACH. FLORIDA. **ADOPTING TENTATIVE** BUDGETS FOR THE **FISCAL** THROUGH COMMENCING OCTOBER 1. 2011 **PURSUANT FLORIDA** SEPTEMBER 30, TO STATUTE 200.065 (TRIM BILL); PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, said public hearing, as required by Section 200.065(2)(c), was held by the Town Council on September 14, 2010, commencing at 7:00 p.m., as previously noticed and the public and all interested parties having had an opportunity to address their comments to the Town Council and the Town Council having had an opportunity to amend the tentative budgets as it deemed appropriate and having considered the comments of the public regarding the tentative budgets and having complied with the "TRIM" requirements of the Florida Statutes.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA AS FOLLOWS:

<u>Section 1</u>. Upon final adoption of the proposed millage rate, which is hereby ratified, the attached tentative budgets of the Town of Golden Beach for the fiscal year commencing October 1, 2010 are hereby approved and adopted.

**Section 2.** This resolution shall be effective immediately upon adoption.

Section 3. That a public hearing to adopt the final budgets for the fiscal year will be held at One Golden Beach Drive, Golden Beach, Florida on Tuesday, September 28 at 7:00 p.m.
