Resolution No. 2150.10- Approving Amendment #1 to the 2010-

2011 Fiscal Year Operating Budget

Recommendation:

It is recommended that the Town Council adopt the attached Resolution No. 2150.10 as presented.

Background:

As we prepared the Town's Capital Budget there were some projects that we listed as either our short-term or long-term projects that we believe we are prepared to fund at this point in time to move the projects forward. The Town's Capital Projects Fund has in reserves \$2,546,175.00 that are available to accelerate two very important projects.

I am requesting that you amend the Capital Budget and allocate \$546,500 for a Town Wide Street Lighting Project. The purpose of this project is to replace the existing street lights within the Town. This Item does not authorize any contracts, but funds the Project allowing us to begin discussions and prepare for your future consideration a full street light replacement project for the Town.

I am also requesting that you amend the Capital Budget and allocate \$100,000 for Improvements at Singer Park and the Massini Fence Line. This Item will allow us to commence enhancements to Singer Park and the Massini Fence Line. Our scope of work includes but is not limited to: installation of irrigation at sites, enhanced landscaping, lighting, site furniture, and site improvements needed to conceal the new FPL transformer farm at Singer Park.

Financial Impact:

\$646,500.00 from the \$2,546,175.00 available in the Capital Budget Reserves; I have attached the Towns Capital Budget as originally Approved and as Amended if approved.
