RESOLUTION NO. 2170.11

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, RECOGNIZING MAY 15th AS PEACE OFFICERS MEMORIAL DAY, AND MAY 15th THROUGH MAY 21st AS NATIONAL POLICE WEEK; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in October of 1962, Congress passed and President John F. Kennedy signed into law a bill that designated May 15th of each year as “Peace Officers Memorial Day,” when the entire nation is called upon to pay homage to the dedicated men and women in the law enforcement profession who have been killed in the line of duty; and

WHEREAS, the National Law Enforcement Officers Memorial reports that the total number of law enforcement officers killed in the line of duty has reached 19,203 nationwide, which includes 743 officers in Florida, and 127 officers in Miami-Dade County; and

WHEREAS, the residents and the Town Council of Golden Beach desire to honor the memory of those law enforcement officers who have died in the line of duty and in furtherance of their commitment to serve and keep others safe; and

WHEREAS, on May 15th, “Peace Officers Memorial Day”, and the week of May 15th through May 21st, “National Police Week”, the Town of Golden Beach and its residents desire to recognize and express their deep gratitude and appreciation to all law enforcement officers, including all officers who have given their lives in the service of others.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. Recitals Adopted. That each of the above-stated recitals is hereby adopted and confirmed.

Section 2. Peace Officers Memorial Day and National Police Week Recognition. That May 15, 2011 is hereby recognized as "Peace Officers Memorial Day," and May 15th through May 21st, 2011 as "National Police Week" in the Town of Golden Beach. In observance thereof, the Town Council calls upon its residents to join in the observance and continued recognition and appreciation of all law enforcement officers who serve the Town and ensure the well-being and safety of the Town's residents and enhance the quality of life in the Town.

Section 3. Implementation. That the Town Manager and Town Clerk are hereby authorized to implement the terms of this Resolution.

Section 4. Effective Date. That this Resolution shall be effective immediately upon adoption.
