

Miami-Dade FIRE RESCUE: SERVING GOLDEN BEACH

Emergencies can strike unexpectedly whether it's a slip and fall, a fire in the kitchen or a collision on the road; it's always good to know that help is close by. Miami-Dade Fire Rescue (MDFR) services Golden Beach and our neighboring municipalities through local stations. MDFR is an Internationally Accredited Agency through the Commission on Fire Accreditation International (CFAI), and is one of only 217 agencies to receive such recognition. The department is the largest accredited fire-rescue department in the Southeast, and the second largest in the United States.

Miami-Dade Fire Rescue has supplied the Town with its latest service statistics for the 2014 and 2015 calendar years. We would like to thank MDFR for their continued efforts and assistance to the Town and its residents.

Table I shows the types of incidents called in to the department and the average response times:

Table II shows the local stations that respond to emergencies within the Town. Sunny Isles Station 10 responds to the bulk of emergencies within Golden Beach with additional support coming from the Aventura stations.

ADDITIONAL STATISTICS:

- In 2015 alone, MDFR dispatched 29 firefighters and nine units to structure fire incidents within the Town of Golden Beach.
- In case of medical emergencies, MDFR's Advance Life Support units average an eight minute lead time from the time an Emergency Medical Service call is placed and arrival.
- MDFR's closest rescue unit is housed 1.51 miles south of Town in Sunny Isles Beach at 175th Street.









Police BEAT



ith spring officially upon us, it's important to remember that the summer months are not far behind. Along with warmer

temperatures comes many warnings, specifically with sun protection. Sunlight has a profound effect on the skin.

It can cause premature skin aging, skin cancer and various other skin issues. Many changes in the skin that were commonly believed to be due to aging, such as bruising easily, are actually a result of prolonged exposure to UV radiation. Exposure to ultraviolet light - UVA or UVB – from the sun's rays accounts for 90 percent of premature skin aging symptoms. So remember to use the proper clothing to protect yourself from the sun, stay hydrated and use sunscreen.



with summer sun also comes the possibility of seasonal storms, which can lead to a host of problems in their aftermath. Natural disasters such as hurricanes and tropical storms, tsunamis, floods, and landslides that impact U.S. coasts can be overwhelming source of waterway debris. High winds, storm surge and heavy rains can uproot household products, lawn furniture, and in the most extreme cases, even

entire homes and other structures can be sent into the surrounding waters. Immediate action is needed to assess and remove the debris in order to maintain navigation routes, ensure safe boating and recreational activities and protect sensitive ecosystems.

Through the Regional Response Planning Project, the National Oceanic and Atmospheric Association's (NOAA) Marine Debris Program is partnering with federal, state and local agencies to improve preparedness for response to and recovery from acute waterway debris incidents resulting from natural or technological disasters. I would like to remind all residents to register and/or update their existing emergency contact information with the Town. In order to do so, visit the Town's website (www.goldenbeach.us) and click the Code Red link at the bottom of the page. Current emergency contact information is critical during unforeseen events, emergency evacuations and unusual occurrences.

The Department is also continuously striving to provide better service to our residents. In hopes of easing traffic concerns, Police Chiefs from neighboring municipalities have joined forces to share information between departments regarding significant traffic incidents, events or issues that could cause delays or traffic congestion. This information will also be passed along to residents through the Code Red system. One such event includes an upcoming construction project that is scheduled to begin in August 2016 on I-95 between I-595 and Broward Boulevard. There are three phases to this project and the contract duration is scheduled to last 1400 calendar days (approximately 4 years). In March, the Golden Beach Police Department along with the Florida Department of Motor Vehicles hosted a one-day driver's license renewal service at the Beach Pavilion. Residents





were excited to see the Town sponsoring this type of event and over 20 of them showed up to take advantage of this unique opportunity.

The Golden Beach Police Department recently received a major accolade for two of its officers. The Department would like to publicly recognize Officer Julio Fernandez and Officer Joseph Bautista who won the 2016 Law Enforcement Officer (LEO) of the Year Award at a ceremony held at Miami's Jungle Island. This marks the first time that officers from the Golden Beach Police Department have won the Dade County Chief's Association Officer of the Year award. In 2011, Sheila Pirrone, the Executive Assistant to the Chief of Police, won a LEO award in the "Support Services" category. We are extremely proud of the accomplishments of our entire department over the last year, and it is a tremendous honor to have not one but two of our officers recognized by such a prestigious organization. The LEO Awards are given by The Law Enforcement Charitable Foundation and are considered the barometer of success and accomplishments in the law enforcement field. Lieutenant Yovany Diaz and I were proud to have accompanied both officers as they received their awards.

GBPD Teams Up with Florida DMV



Having your license renewed was never this easy. Savvy residents saved themselves a trip to the Department of Motor Vehicles office recently by taking advantage of a special event which partnered the Golden Beach Police Department with the Florida DMV. Police Chief Rudy Herbello organized the March 18th event, saying it was a way of offering convenience and specialized service to our residents. With portable mobile stations set up at the Beach Pavilion, residents were able to update their documents virtually in their own back yard. The Town hopes to offer the service again, possibly making it an annual event.













Sea Grapes & Sea Turtles in Golden Beach:

When a little landscaping can get you in a lot of trouble

We must admit life in Golden Beach is luxurious. With our picturesque beaches and waterways, beautiful surroundings

and weather, what's not to love? Though we live in idyllic environs we must remember that there is a degree of responsibility on our part to preserve that beauty. Care should be taken not to disrupt the plants and animals that also make our Town their home. Certain plants are protected by laws created by the Florida Department of Environmental Protection. One of these protected plants is the Coccoloba Uvifera or the sea grape. These plants are native to Florida and are often found on the coastline. Sea grape plants are remarkably beneficial to the natural environment, and for that reason they are given protected status. With its waxy leaves and grape-like clusters of fruit, it provides a habitat and sustenance for various native species, including song birds and gopher tortoises. It also serves as a natural stabilizer to our beaches, preventing erosion, all while providing a lush, shady canopy.

The sea grapes also play a major role in the nesting habits of the endangered sea turtles. In Miami-Dade County, sea turtles begin laying eggs around the 1st of April and the last of the hatchlings head out to sea around Halloween. Sea turtles spend most of their life out in the open ocean, but in order to lay their eggs they must return to the shore. Under the shroud of darkness a female sea turtle will crawl from the ocean, dig a shallow nest, deposit around 100 eggs in the sand, bury them, and return to the ocean. After approximately 60 days the turtles will hatch, work their way to the surface, and paddle out





to the rolling waves. If you are lucky you may spot on one of these little hatchlings as they begin their journey. Last year, residents were excited to have spotted multiple hatchlings traversing the sands of Golden Beach.

The sea grape's role is vital in the nesting process of these endangered animals. Just like the sea grape plant provides shade from the glaring midday Florida sunshine, it also provides protection from artificial lighting at night, a time where the sea turtles are most active. Artificial light refers to anything from porch lights, security lights and even indoor lighting that spill out of open windows and glass doors. The large leaves and bushy branches of the sea grape help keep our light where it belongs and out of nesting areas where it can do harm. This light can be considered a form of pollution, as it can have extremely detrimental effects on the nesting environment. Bright lights deter female turtles from coming ashore to nest. Artificial light also disorients the turtles; turtles use instinctive visual cues from natural light to orient themselves to the land and the ocean. When these natural cues are overridden the animals can become lost and the effects are often fatal. The Florida Fish and Wildlife Commission reports that nearly 20,000 to 30,000 hatchlings disorient due to artificial light infiltration every year. The hatchlings lose their way and become victims of exhaustion, dehydration, predation, or sadly being hit by cars as they try to find their way back to the open waters. For an endangered species it is especially critical that we do our best to encourage a safe habitat for reproduction. The sea grapes along with turtle-safe lighting help to minimize the potential damage to the nesting process caused by human presence.

The handling of sea grapes is a serious matter. If you have sea grape bushes on your property and you wish to trim or alter them in any way, you must apply for a permit to do so. Unpermitted trimming or alteration is considered interference with the normal nesting behavior of an endangered species and can result in fines and/or imprisonment under the Endangered Species Act (1973) and Florida Statutes 161 and 370.12. Feral cats are an essential part of beach communities as they are natural hunters who serve to control populations of rodents and other vermin. If feral cats' natural inclination to hunt for their food is altered by human intervention through feeding they can become a nuisance. Feral cats' numbers can skyrocket along with numbers of the pests they would typically prey upon if they were still hunting instead of being fed. As we are looking to treat and control the population we ask for cooperation from residents to please refrain from feeding these animals, keep in mind that setting up feeding areas outside of your own property is strictly prohibited. Please be aware that the Golden Beach Police Department will fine anyone caught feeding feral cats \$250.00 without issuing a warning. PLEASE NOTE: Residents who have been approved through Town Hall as participating hosts for catch and release sites are exempt from citations for feeding. Please contact Michael Glidden at Town Hall (mglidden@goldenbeach.us) if you would like your home to be added to the list of approved feeding sites.

It is wise not to approach feral cats; their lack of domestication can make them aggressive and unpredictable especially if they feel cornered or threatened.

The Town's ongoing initiative is to humanely trap, treat, neuter and return the cats, as long as they are healthy. This initiative will help to create a cat population that is appropriate for a community our size. We are looking for homeowners who have noticed feral cats congregating on their properties and who would be willing to have live traps set up around the outside of their homes. Please contact Town Hall if you are interested.

The Town is sensitive to the concerns of residents that these animals be treated in a humane manner and we assure you that the intention is to help all of the animals that are healthy and not to euthanize unless completely necessary. The Town is also open to suggestions and recommendations as we look to humanely control the Town's cat population. We ask for your cooperation during this process.

Register Your Furry Friends

Unloading those groceries from the car, running back from the pool when you hear your cell phone ringing inside, or wheeling out the recycling bin. To you these may seem like mundane daily moments. However, to your pets these are golden opportunities to scramble out into the world and explore around the neighborhood.

Unfortunately pets' curiosity can get them into trouble because sometimes they wander far from home and can't find their way back. Often times we are contacted at Town Hall by homeowners who have found a wayward pooch wandering in their backyard, a furry friend who looks confused and just wants to find her way home. If animals do not have their owner's information, name, address, phone number displayed on their collars, or any kind of active microchip identifier we are left to wait to see if their owners call for them.

The Town would like to make reuniting residents with their pets as easy as possible. We are asking residents to consider submitting photos of their pets along with owner contact information (name, address, cell phone) to Town Hall, so that we may compile a database to help pets find their way back home if they get lost.

Please be as thorough as possible as adequate information is essential for reuniting lost pets with their owners.

Ongoing Iguana Treatment throughout Town

Due to multiple requests from residents, the Town is continuing its iguana control initiative. The Town has representatives from Trutech Wildlife Control exploring areas of concern. Technicians will be surveying parts of Town where iguanas are likely to gather most or have been spotted congregating, particularly along sea walls. Please be aware that technicians may be armed with air rifles during the eradication process. We ask for your cooperation in granting access to your yards for these authorized technicians during this process. PLEASE NOTE that the iguana control process will thin the number of iguanas over time and should not be considered an immediate extermination of all iguanas in Town.

If you are having issues with iguanas and would like the Town to dispatch the iguana service to your home on the next scheduled visit please email mglidden@goldenbeach.us with your name, address, and contact number to be added to list. ALSO NOTE that the Town is currently enrolled in a once-a-month iguana service contract and cannot add isolated spot visits in between scheduled service dates. Should residents feel their iguana problem needs immediate attention they are encouraged to hire their own iguana services at their own expense.

Changes at Tweddle Park: What to Expect

As you may have noticed construction is underway at Tweddle Park. We ask for residents to bear with us as we help bring updates and improvements to various areas of the park over the next coming months. During construction certain areas will not be available for use. The tennis courts and dog park will be affected most.

Upon completion of the renovations, new regulations will be applied to use of the park and its facilities. These regulations are specifically intended to give residents better access to the Town's amenities. The Town wants to eliminate past issues including non-residents using the tennis courts without being accompanied by a Golden Beach resident. Tennis courts will only be available for residents and their accompanied guests & instructors. Use of courts by unaccompanied non-residents will be strictly prohibited at all times. Instructors or guests of residents will not be allowed to use the tennis courts without the resident being present. New signs which clearly explain the policy will be installed throughout the park. This restriction is to give residents exclusive access and to alleviate congestion at the courts.

The new policy along with changes to the Town's pedestrian gate codes will help to offer residents a better park experience.

Pedestrian Gates Codes Change


The Town has changed the access codes to its pedestrian gates. Going forward, the code will be given through calling Town Hall. In order to provide maximum effectiveness for this security feature, the Town asks that residents NOT casually share the gate code. Please use discretion in giving out the code to household staff and ask that they not share the code with others. The pedestrian gates are in place to preserve the security and integrity of the Town and its facilities; offering the code to strangers undercuts the Town's efforts to protect the community.

Please also note that attempting to deactivate or manipulate the locking mechanism on the gate is considered vandalism and destruction of Town property, and is also an arrestable offense. Alert household staff that the Town will be enforcing a zero-tolerance policy with anyone found to be damaging the gates. We appreciate your understanding and cooperation in this matter.


