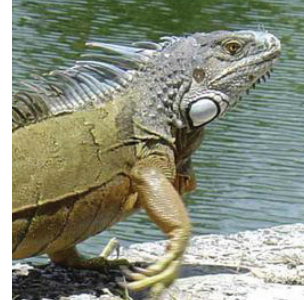

Water Quality Report

RELEASED BY NORTH MIAMI BEACH WATER

The City of North Miami Beach is the supplier of water to Golden Beach and recently released their official statistics for local water quality for the 2015 calendar year. Water was tested for potential contaminants present, including microbiological contaminants (bacteria), trace metals (copper and lead from plumbing), inorganic compounds (both naturally occurring and from manmade origins), along with disinfectants and disinfectant byproducts (which make their way into water as a result of treatment).

Across the board, the water in Golden Beach scored better than both state and federal requirements. The table below shows the comparisons of Maximum Contaminant Levels (MCL) for the categories tested, and the limits set by both the Federal and State requirements. The column listed as “NMB Water - Norwood Water Treatment Plant” shows the statistics that apply to the water that is supplied to Golden Beach. The Legend, Abbreviations/Definitions, and Units section help to support the table.

Units

pCi/l - PicoCuries Per Liter: measure of the radioactivity in water.

ppb - Parts Per Billion: one part by weight of analyte to 1 million parts by weight of the water sample.

Abbreviations and Definitions

AL - Action Level - The concentration of a contaminant which, if exceeded, triggers treatment or other requirements that a water system must follow.

Disinfection - In treating water, it is the process by which water is exposed to a chemical for a specified time period to kill pathogenic organisms.

Disinfection By-Product - A chemical produced by the disinfection process. Disinfection by-products are regulated and are indicators of potential carcinogenic substances.

MCL - Maximum Contaminant Level - The highest level of contaminant that is allowed in drinking water. MCLs are set as close to MCLGs as feasible using the best available treatment technology.

MCLG - Maximum Contaminant Level Goal - The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

MRDL - Maximum Residual Disinfectant Level - The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants, which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

MRDLG - Maximum Residual Disinfectant Level Goal - The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

NE - Not Established

N/A - Not Applicable

ND - Means not detected and indicates that the substance was not found by laboratory analysis.

Police BEAT

May is a month of remembrance; Memorial Day for our fallen soldiers on May 30th and Peace Officers Memorial Day recognizing officers who give their lives in the line of duty on May 15th. To honor our fallen officers I attended the Police Memorial Day at Tropical Park on May 5th.

The event was organized by the Police Benevolent Association and the Fraternal Order of Police. During the entire month of May, respect is paid to fallen Police Officers nationwide; Roll Call is read not only to commemorate the loss to the community, co-workers and family members, but also to remember how they lived and to celebrate their lives. The resounding message is: "It is not how these officers died that made them heroes, it is how they lived."



Today, in the United States, more than 900,000 law enforcement officers put their lives on the line for the safety and protection of others. They serve with valor and distinction – and with great success. Federal statistics show that both violent and property crime rates in the United States are at historic lows, thanks in large measure to the dedicated service of the men and women of law enforcement.

That protection comes at a price, however. Each year, there are approximately 60,000 assaults on law enforcement officers, resulting in nearly 16,000 injuries. Sadly, over the last decade an average of 146 officers have been killed in the line of duty each year. Approximately one law enforcement officer is killed in the line of duty somewhere in the United States every 61 hours.

The National Law Enforcement Officers Memorial is located in Washington, DC and serves as the nation's monument to

law enforcement officers who have died in the line of duty. Dedicated on October 15, 1991, the Memorial honors federal, state and local law enforcement officers who have made the ultimate sacrifice for the safety and protection of our nation and its people.

The Memorial features two curving, 304-foot-long blue-gray marble walls. Carved on these walls are the names of more than 20,000 officers who have been killed in the line of duty throughout U.S. history, dating back to the first known death in 1791. Unlike many other memorials in Washington, DC, the National Law Enforcement Officers Memorial is ever-changing: new names of fallen officers are added to the monument each spring, in conjunction with National Police Week.

Back here at home, I would like to advise all residents that that the Florida Department of Highway Safety and Motor Vehicles (DHSMV) is partnering with many Law Enforcement Agencies, the Florida Department of Transportation, Florida Sheriffs Association, Florida Police Chiefs Association, Florida SADD and the Florida Teen Safe Driving Coalition stressing an awareness in youth distracted driving. In 2015, there were more than 45,700 distracted driving crashes in Florida resulting in more than 39,000 injuries and more than 200 fatalities. Distracted driving crashes accounted for 12.2 percent of all crashes in Florida last year, 7.4 percent of fatal crashes and 15.4 percent of all injury crashes.

Recently the Golden Beach Police Department underwent a mock-assessment of their policies and procedures by members of the Commission for Florida Law Enforcement Accreditation. The assessment was successfully completed and resulted in revisiting and updating some existing policies.

The official On-Site Assessment is scheduled for August 2016. We encourage residents to submit comments regarding our department for the assessors to review. Comments may be

submitted via email or letters and can be sent to our police station, located at 1 Golden Beach Drive, or mailed directly to the Commission for Florida Law Enforcement Accreditation, Inc. P.O. Box 1489, Tallahassee, Florida, 32302 (www.flaccreditation.org).

I would also like to use my column in the Town's magazine to bring awareness to residents about legislative changes occurring here in the state of Florida. With each issue, I will detail one of the statutory changes enacted by the Florida House and Senate. Below is a case summary of one of the legislative changes related to traffic and motor vehicle laws that was enacted during the 2016 Legislative Session.

“SB 158 – Identification Cards and Driver Licenses

Allows individuals who hold and present a lifetime freshwater fishing license, a lifetime saltwater fishing license, a lifetime hunting license, a lifetime sportsman's license, or a lifetime boater safety identification card to have a symbol displaying that lifetime status voluntarily added to his or her driver license or identification card.

When the driver license or identification card is being issued, renewed, or replaced for a purpose other than solely including the recreational symbol on the card (i.e., an address or name change), adding the symbol requires the payment of a \$1 fee, in addition to the applicable issuance, renewal or replacement fee. An individual who surrenders and replaces his or her driver license or identification card for the sole purpose of including his or her status as a lifetime fishing, hunting, or sportsman's licensee holder or a lifetime boater safety cardholder is only required to pay a \$2 fee.

Changes made will apply upon implementation of new designs for the driver license and identification card allows the state-issued identification card or driver license displaying the lifetime designation to be used as proof of possession of that lifetime license or card.”

Attention Dog Owners

Due to increased issues, the Town is taking an aggressive stance on dog owners who do not pick up after their pets.

Curbing your dog is not just a courtesy, it is also the law. Please be aware that the Town is employing plainclothes officers (police officers dressed as civilians) to monitor the Town, in an effort to combat this serious health and safety hazard. Whether in the Town's right-of-ways, parks, or on private properties, these officers will be issuing citations without warnings to anyone who does not pick up their pet's waste. Citations are \$150.00 per offense. Pet waste bag stations are available throughout Town. Avoid citations, be a responsible pet owner and clean up after your animals. Help us keep Golden Beach clean!

Cat Treatment Progresses

The Town continues its efforts to manage its feral cat population. We have already had marked success with the program since efforts began back in April. We have treated more than 25 animals and prevented over 16 new kittens from being added to the Town's already existing population.

The Town's ongoing initiative is to humanely trap, treat, neuter and return the cats, as long as they are healthy. This initiative will help to create a cat population that is appropriate for a community our size. Please be aware that the treated animals are returned to the area they were collected; Florida State Law prohibits relocating animals from their native habitat under its cruelty to animals legislation (Florida State Statute 828.12 and 828.13). Anyone convicted of animal cruelty is subject to fines of up to \$5,000 and/or up to 5 years in prison.

Golden Beach homeowners who have noticed feral cats congregating on their properties and would be willing to have live traps set up around the outside of their homes may contact Michael Glidden at Town Hall (mglidden@goldenbeach.us) to have their home added to the list of approved feeding/trapping sites.

We ask for your cooperation during this process.

Register Your Furry Friends

Unloading those groceries from the car, running back from the pool when you hear your cell phone ringing inside, or wheeling out the recycling bin. To you these may seem like mundane daily moments. However, to your pets these are golden opportunities to scramble out into the world and explore around the neighborhood.

Unfortunately pets' curiosity can get them into trouble because sometimes they wander far from home and can't find their way back. Often times we are contacted at Town Hall by homeowners who have found a wayward pooch wandering in their backyard, a furry friend who looks confused and just wants to find her way home. If animals do not have their owner's information, name, address, phone number displayed on their collars, or any kind of active microchip identifier we are left to wait to see if their owners call for them.

The Town would like to make reuniting residents with their pets as easy as possible. We are asking residents to consider submitting photos of their pets along with owner contact information (name, address, cell phone) to Town Hall, so that we may compile a database to help pets find their way back home if they get lost.

Approaching Summer Months See Iguana Reports Rise

Iguanas tend to become more active, and visible, as the sunnier summer days begin approaching. Residents who are having issues with iguanas on their property are asked to contact Town Hall to be placed on the Town's iguana treatment site list. Iguanas are a non-native Florida species and can be considered a nuisance as they may eat flowering plants and fruit, enter swimming pools and hot tubs, or leave waste around yards.

If you are experiencing issues with iguanas on your property you can send your name, address, and contact information to Michael Glidden at Town Hall at mglidden@goldenbeach.us. The Town currently has a monthly service agreement with Trutech Wildlife Removal. Residents who have issues that extend past the scope of the Town's monthly service visits are encouraged to seek their own supplemental treatment services from a licensed exterminator. Though considered an invasive species, iguanas are still protected under Florida's cruelty to animal statutes; inhumane treatment could result in a stiff fine and possible jail time; residents should under no circumstances take it upon themselves to kill iguanas.

Zika Virus Updates

The Town has renewed its contract with Clarke, a mosquito control service provider, which will include monthly spraying Town-wide during the months of June through September. Clarke has also supplied the Town with some important facts on how to help keep your yard mosquito-free from the *Aedes aegypti* and *Aedes albopictus* mosquitos - breeds that are known to be carriers of the Zika virus.

These mosquitos can lay eggs in items as small as an overturned bottle cap! They need a minimal amount of standing water to lay their eggs, so check your yard for any place water can collect; Don't forget about little items like flower pots, pet food bowls, gutters, bird baths, watering cans, etc.

These breeds of mosquitos have atypical feeding patterns. They tend to bite during the day, unlike many other breeds of mosquitos that feed after the sun has set.

Being proactive about your property protects you most of all. *Aedes* mosquitos tend to bite close to their breeding grounds, so allowing them to breed on your property increases your risk of being bitten.
