A RESOLUTION OF THE TOWN OF GOLDEN BEACH, FLORIDA, GRANTING A VARIANCE TO WAIVE TOWN CODE SECTION 66-136, SIDE SETBACK REQUIREMENTS, TO PERMIT THE NORTH SIDE SETBACK FOR A NEW BEDROOM TO BE SEVEN FEET FOUR INCHES (7'4") IN TWO LOCATIONS WHERE A TEN FOOT (10') SETBACK IS REQUIRED AND A VARIANCE TO WAIVE TOWN CODE SECTION 66-136, SIDE SETBACK REQURIEMENTS, TO PERMIT THE SOUTH SIDE SETBACK FOR A NEW GARAGE TO BE AT SEVEN FEET ZERO INCHES (7'0") WHERE TEN FEET (10') IS REQUIRED FOR **EMANUEL** AND GOLDSZMIDTH, 260 SOUTH ISLAND DRIVE, LOT 44 AND THE NORTH 1/2 OF LOT 45, BLOCK J, GOLDEN BEACH SECTION "D", GOLDEN BEACH, FLORIDA, AS RECORDED IN PLAT BOOK 10 AT PAGE 10 OF THE PUBLIC RECORDS OF MIAMI DADE COUNTY, FL.

WHEREAS, Emanuel and Estrella Goldszmidth have applied for the following:

A VARIANCE requesting relief from Town Code Section 66-136, Side Line Restrictions, to permit the north side setback for a new bedroom to be seven feet four inches (7'4") in two locations where a ten foot (10') side setback is required, and

A VARIANCE requesting relief from Town Code Section 66-136, Side Line Restrictions, to permit the south side setback for a new garage to be at seven feet zero inches (7'0") where a ten-foot setback (10') is required.

WHEREAS, upon due and proper consideration having been given to the matter, it is the opinion of this Town Council that the requested variances are not contrary to public interest and that special conditions do exist whereby a literal enforcement of the provisions of the Town's Code of Ordinances will result in unnecessary and undue hardship on the applicant.

NOW, THEREFORE BE IT RESOLVED by the Town Council, of the Town of Golden Beach:

Section 1. That the requested variance is hereby approved as follows: To permit relief from Town Code Section 66-136, Side Line Restrictions, on the north side to permit a new bedroom to be seven feet four inches in two locations where a ten foot setback is required by the Town Code.

Section 2. That the requested variance is hereby approved as follows: To permit relief from Town Code Section 66-136, Side Line Restrictions, on the south side to permit a new garage to be seven feet zero inches where ten feet is required by the Town Code.

Section 3. That the application as approved, is subject to the following conditions:

A. A Building Permit for work where the Variance has been granted must be obtained within two (2) years from the date of Variance approval. If no Building Permit is issued within the two (2) year time limit, then the Variance approval will be null and void.

Section 3. The Building and Zoning Director is hereby directed to make the necessary notations upon the maps and records of the Town of Golden Beach Building and Zoning Department and to issue all permits in accordance with the terms and conditions of this Resolution. A copy of this Resolution shall be attached to the building permit application documents.
