

**GOLDEN BEACH, FLORIDA**

**RESOLUTION NO. 1157.99**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, APPOINTING DEPUTY TOWN CLERK ROSEMARY J. WASCURA, CMC/AE TO TOWN CLERK, ENDING THE APPOINTMENT OF AN INTERIM TOWN CLERK; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, pursuant to Resolution No. 1146.98, the Town Council on October 20, 1998 appointed Rosemary J. Wascura as Deputy Town Clerk, effective November 9, 1998; and

**WHEREAS**, Rosemary J. Wascura has served as Deputy Town Clerk and is qualified to serve as Town Clerk; and

**WHEREAS**, Town Manager Carole S. Morris has recommended to the Town Council that Rosemary J. Wascura be promoted to Town Clerk;

**NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:**

**Section 1.** That the above stated preambles are true and correct and are hereby adopted in this resolution.

**Section 2.** That pursuant to Sec. 3.04(d) of the Town Charter, Rosemary J. Wascura, CMC/AE is hereby appointed Town Clerk, effective Wednesday, January 20, 1999, with all the duties and responsibilities as provided in the Town Charter, ordinances, resolutions and applicable state statutes.

**Section 3.** That Town Clerk Rosemary J. Wascura shall receive a \$2,000 annual salary increase effective the first full payroll period after taking office. That all employment benefits and conditions not conflicting with this resolution, as provided in Resolution 1146.98 are hereby ratified.

**Section 4.** That Town Manager Carole S. Morris is hereby relieved of her duties as Interim Town Clerk, effective January 20, 1999, with the thanks of the Town Council for serving in a dual capacity.

**Section 5. Severability.** That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

**Section 6. Conflict.** That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.


**Section 7. Effective Date.** That this Resolution shall become effective immediately upon approval of the Town Council.




