

**TOWN OF GOLDEN BEACH, FLORIDA**

**RESOLUTION NO. 1161.99**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, APPOINTING A REPRESENTATIVE TO THE MIAMI-DADE COUNTY LEAGUE OF CITIES FOR A ONE YEAR PERIOD FROM MARCH, 1999 TO MARCH 2000; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the Miami-Dade County League of Cities represents the municipalities of Miami-Dade County both at a local level and in the Florida Legislature; and

**WHEREAS**, each municipality is represented by a member of its' Council at regular meetings and special events; and

**WHEREAS**, it is the recommendation of the Mayor of the Town of Golden Beach to appoint Councilwoman Sara Chikovsky as the representative of the Town until March, 2000.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA:**

**Section 1.** That Councilwoman Sara Chikovsky be and is hereby appointed as the Town of Golden Beach representative to the Dade League of Cities until March 2000.

**Section 2. Severability.** That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

**Section 3. Conflict.** That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

**Section 4. Effective Date.** That this Resolution shall become effective immediately upon approval of the Town Council.


