

RESOLUTION NO. 1170.99A

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA CODIFYING THE PORTION OF THE MIAMI-DADE COUNTY CHARTER TITLED "CITIZENS BILL OF RIGHTS" SECTIONS 1-9, INCLUDING THE PREAMBLE, AS AN ATTACHMENT TO THE GOLDEN BEACH TOWN CHARTER; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, there exists a "Citizens Bill of Rights"; in the Charter of Miami-Dade County, which applies to the County and, in part, to the municipalities in the County, including the Town of Golden Beach; and

WHEREAS, the Town is not adopting or enacting this "Citizens Bill of Rights" Sections 1-9 but desires to publish it in the Town's Code Book to be available for all interested parties to note when there is reference to the Town's Charter;

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. That the portion of the Miami-Dade County Charter titled "Citizens Bill of Rights" Sections 1-9 (including its Preamble), shall be published and included with the Golden Beach Town Charter as "Attachment 1" to the Town Charter. The codifier (Municipal Code Corporation) is directed to print copies of the "Citizens Bill of Rights" Sections 1-9 (and Preamble) to be included in the next supplement of the Town Code. A reference in the Table of Contents and the Index of the Town Code Book shall also be made. The Municipal Code Corporation is requested to include the legislative history and footnotes and to update the text if amendments occur in the future, until further notice by the Town of Golden Beach.

Section 2. This Resolution does not enhance or diminish the jurisdiction of the "Citizens Bill of Rights". It continues to have whatever jurisdiction or authority as it has as part of the Miami-Dade County Charter.

Section 3. The Town Clerk, as custodian of the records, is authorized and directed to supply a copy of this Bill of Rights Sections 1-9 and Preamble whenever a copy of the Town's Charter is requested to be produced or purchased.

Section 4. That a copy of the "Citizens Bill of Rights" (and Preamble) is attached to and made a part of this Resolution as "Attachment 1" .

Section 5. Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

Section 6. Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 7. Effective Date. That this Resolution shall become effective immediately upon approval of the Town Council.


The Motion to adopt the foregoing Resolution was offered by Councilmember Feinman, seconded by Vice Mayor Paruas and on roll call the following vote ensued:


