A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA; APPROVING THE SALE OF FIVE SURPLUS POLICE VEHICLES TO BIG BEAR CRUISERS, THE HIGH BIDDER, IN LIEU OF AN AUCTION OR TRADE-IN; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING AN EFFECTIVE DATE.

BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. That the Police Chief and the Town Manager, having declared these items surplus property, the sale of five (5) Ford Crown Victoria police vehicles with model years ranging from 1992 - 1996, as listed on the attached Exhibit 1 to this Resolution, to Big Bear Cruisers for the total amount of \$20,708.00 is hereby approved.

Section 2. That since the Town solicited three bids, and this sale is to the highest bidder, disposal methods of auction or trade-in are hereby waived, as provided in Town Code Sec. 2-308.

<u>Section 3.</u> That the appropriate Town Officials are hereby authorized and directed to execute the necessary documents, including motor vehicle titles, for the sale of these automobiles.

Section 4. Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

Section 5. Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

<u>Section 6.</u> Effective <u>Date.</u> That this Resolution shall become effective immediately upon approval of the Town Council.
